INITIAL TRAINING TO QUALIFY FOR DEP CERTIFICATION IN EROSION CONTROL PRACTICES

Maine law requires a contractor filling or disturbing soil in the municipal shoreland zone have a DEP-certified individual responsible for erosion and sediment controls on-site each day until the site is permanently stable. Completion of Maine DEP's 8-hour course "Basic & Advanced Erosion Control Practices" is the first requirement of certification.
