# **Overarching Objectives:**

- Increase bicycle tourism and improve the economies of the communities of Detroit and Estacada
- Increase rider's awareness of the untouched scenic beauty and recreation opportunities readily available in the upper Oregon Cascades area
- Connect the communities of Detroit and Estacada via the Cascading Rivers Bikeway

### **Business Target Markets:**

The anchor points of the Cascading Rivers Bikeway are Detroit and Estacada. The communities differ from each other and have much to offer riders. Because of the distance separating the towns and the differences within each, the Committee has appointed Liaisons from each of the communities to work with businesses and raise awareness of the Cascading Rivers Bikeway. Below see active community businesses and their appointed liaison.

### **Cyclist Categories:**

The Cascading Rivers Bikeway is categorized as a challenging ride for the experienced rider. The route covers approximately 72 miles with a total elevation climb of about 6,500 feet and over 5,300 feet of descent. Riders may choose to complete the ride in one day or linger for an extended trip. A number of camping areas with vault restrooms and water are available along the first 30 miles of the bikeway from Estacada. Seasonal stores at Promontory Park (7 miles southeast of Estacada) and Ripplebrook (26 Miles southeast of Estacada) have food, maps and supplies. This ride will be attractive to the following types of riders:

Touring Cyclists

- Ride Focused Cyclists
- Adventure Cyclists

It should be noted that shorter out and back rides are available to riders who wish to picnic or linger on their ride. The initial 18 miles from Estacada has a bike lane and easy gradual ascents. From Detroit, riders may choose to ride approximately 10 miles to the Breitenbush Hotsprings Retreat and Conference Center. It has a slight incline. It is best to call for reservations at Breitenbush.

# Web Action Items and Ongoing Web Communications:

Road updates and camp ground information will be updated by Forest Service staff. Forest Service roads make up a majority of the Cascading Rivers route and will be seasonally closed due to snow. The Forest Service will supply updates to rideoregonride.com and oregonscenicbikeways.org as available. Information can be directly posted to rideoregonride.com and sent to Alex Philips to be posted on the oregonscenicbikeways.org site.

The Cascading Rivers Bikeway will have its own Facebook page which will be managed by a member of the proponent group. Road conditions and other information that cyclists will find useful will be posted as available. This will encourage riders to post photos and experiences on the page. Community events in both Estacada and Detroit will be shared on the Facebook page that will entice riders. This page has already been started and has a number of followers.

The Cascading Rivers Bikeway will be featured on the Proponents web sites- <a href="www.estacadachamber.org">www.estacadachamber.org</a> and detroitlakeoregon.org. Both Willamette Forest Service and Mt Hood Forest Service will have links on the page which will have all campground, road condition and other useful forest land information. The site will list the telephone number and street address to the Estacada Chamber where interested parties can obtain more information. The Estacada Chamber will have trained staff on the basics of the Cascading Rivers Bikeway.

# **General Marketing Action Items:**

The Cascading Rivers Committee decided on several ways to market the Bikeway. Most items are anticipated to start after the official designation has been awarded, however, some have already been generated through the communities.

# **Ride Description**

The Cascading Rivers Bikeway follows the woven Clackamas and Breitenbush Rivers in a 72 mile link from Estacada to Detroit. Water is the dominant force that sculpts the volcanic landscape of the West Cascades. All along this route water and rock interact to create a place of dramatic beauty and inspiration. Rivers, rapids, waterfalls, hot springs and lakes captivate and guide the rider. Time is forgotten as a pausing rider looks up to the sky through

ancient forests that line the bikeway. Where there is water, there is life. Riders may experience glimpses of elk or a fluttering grouse or rest along the route to a symphony of forest songbirds.

The bikeway parallels the nationally designated Wild and Scenic Clackamas River along rocky riffles, quiet pools and reservoirs. Beneath the waters native runs of Coho, Chinook and Steelhead seek their ancient spawning beds. Vistas of Mt Hood and Mt Jefferson smile down upon the exploring cyclist.

Experienced riders who seek a challenge will be most attracted to this 72 mile route of forested splendor paired with a 3,125 foot climb from Estacada and 1,985 foot climb from Detroit. A shorter family-friendly ride is available from Estacada. Those coming from the north or thru Portland Airport will be able to utilize the Portland TriMet system all the way to Estacada. Free parking is available in both Estacada and Detroit. The US Forest Service offices in both Detroit and Estacada offer campsite information and road condition reports. This route is closed during late fall and winter.

Remove the stresses of civilization with a walk through the towns of Estacada or Detroit. Both are full service towns with many options for eating and situated on tranquil waters. Each town is distinctly different but similarly rooted in its historical attachments to water power, mountains and forests.

# **Cautionary Statement:**

**Motorized Vehicle Traffic volume:** Low to moderate, late spring and fall. Higher on weekends and holidays during the summer months.

Important Road Conditions and Traffic Information: Most of the route through the National Forest is narrow, steep and winding with limited to no shoulders. Watch out for truck traffic, fallen rocks or trees, and possible damaged road surface conditions and slippery surfaces during wet or icy weather. In the winter, Road 46 is not maintained for travel. Much of the route is closed by snow late-fall to early spring. Roads are only maintained late spring to fall. Check Road 46 status with local Ranger District offices. Highway 224 conditions can be found on ODOT's trip check website. Cell coverage is extremely limited.

# **Talking Points**

**The Water**- Rivers, rapids, waterfalls, hot springs and lakes captivate and guide the rider. Estacada is close to the River Mill Dam and the Faraday Dam both on the Clackamas River. Likewise the town of Detroit sits on the banks of Detroit Lake which is impounded by the Detroit Dam and the Big Cliff Dam. The Breitenbush and the Santiam Rivers feed into Detroit Lake.

**The Scenery-** Old growth forests, vistas of Mt Hood, Mt Jefferson and the Upper Cascades, flowing rivers and wildlife. Riders may want to enjoy the rebirth of the forest in the spring as greens become more green or the sunset colors of spectacular fall rides.

**The Mind-Set-** Time is forgotten as a pausing rider looks up to the sky through ancient forests that line the bikeway. Where there is water, there is life. Riders may experience glimpses of elk or a fluttering grouse. Rest along the route to a symphony of forest songbirds.

**The Towns**- Remove the stresses of civilization with a walk through the towns of Estacada or Detroit. Both are full service towns with many eating and situated on tranquil waters. Each town is distinctly different but similarly rooted in its historical attachments to water power, mountains and forests.

# **OPRD Public Meetings Summary for Cascading Rivers Recommended Bikeway**

Two public meetings were held by OPRD to get public input on the Cascading Rivers Recommended Bikeway. A media release was sent out approximately three weeks prior to the events, local proponents worked with local media to ensure the release would be printed in the local papers. An announcement was also posted on Oregonscenicbikeways.org and was tweeted.

Previous to the OPRD public meeting two meetings announced publically were held by the proponent groups. These meetings were announced in local media outlets, list serves and newsletters and by the local proponents.

# **OPRD Public Meeting in Estacada:**

3/18/14 - 5:30pm -6:30pm

Approximately twenty eight people attended, including several local proponents, the Park Manager from Milo McIver State Park, a staff person from Clackamas County Tourism and the Mt Hood District Ranger.

The majority of the audience seemed interested in just getting information on the bikeway and other projects, such as the Cazadero Trail. There were no opponents to the bikeway. One citizen attendee did voice concern on the mostly volunteer emergency services in Estacada could get overwhelmed when more people visit the area. Two people from the emergency response department were in attendance for part of the meeting and the Chamber of Commerce keeps them updated on the bikeway.

Clackamas County Commissioner Ludlow did make a statement that the county has almost no money to improve roads because the gas tax is not enough for maintenance. He also voiced his strong support for the bikeway.

One attendee did ask what the peak volume of cyclists will be for the bikeway. OPRD does not have any use counts for any of the bikeways at this time. Another attendee asked if the parking at the Chamber building will be enough. The only parking use information OPRD has is on the Old West because the parking is located at Kam Wah Chung State Park, it is only 3-4 cars per weekend. This bikeway may attract more people. Parking availability will be monitored and if it because a problem other spots in town can be used for parking.

## **OPRD Public Meeting in Detroit**

3/19/14 5 pm- 6 pm

Approximately thirty three people were in attendance, including one local proponent, The Detroit National Forest District Ranger and The Park Manager and Ranger from Detroit Lake.

The audience was very enthusiast about the bikeway's designation and the additional tourist dollars and prestige the bikeway will bring. One attendee said, "This is the most beautiful road you can imagine, and a challenge in just the right ways".

One attendee did ask about the perceived delays in designation. The reason for the delay was the proponent group was inactive for about one year. Two other bikeways that were recommended at the same time in 2011 were designated in May 2013.

Another attendee said, "Bike tourists are quality people who are not rushed and like to take time to talk to locals."

Several attendees commented on the interest in holding a bicycle event to bring people to the area. On attendee asked if there was grant money for bikeways. Recreation Trail Program grants do award five points to projects on a state trail, such as the bikeway. Other grant programs, such as Connect Oregon are becoming more supportive of bicycle project funding.

# Meeting Agenda and Summary

**Describe the Scenic Bikeway Program**: We provided maps and ride descriptions of the currently designated bikeway programs and the goals of the statewide program. We described the Cascading Rivers proposed bikeway.

Locally the goals mentioned were (1) Encourage biking as an economic opportunity to increase tourism spending in the area. (2) Improve quality of life and recreational opportunities and (3) increase opportunities for healthy lifestyles and improved fitness. We described ways that the bikeway might impact positively the local economy. One example mentioned was to increase use of recreation in the National Forest. In a lodging feasibility study of 2009 it was mentioned that US Forest Service campgrounds east of Estacada had a relatively low rate of occupancy (24%) and increased use of campgrounds could increase the use and tourism funds that benefit the US Forest Service and the entire County through collection of the transient room tax. Business in the City of Estacada hopes also to benefit from support facilities and possibly bike tours.

The route was described and we went over the attributes along the route that were illustrated in a pictorial map along one wall.

**Public Involvement**: We described several ways people could be involved by joining the planning group, assisting in activities as volunteers and to help with local promotions. Several people indicated a willingness to help with the project. We will advise them of future meetings.

**Issues and comments:** Most comments were positive and encouraging of the bikeway project. Concerns discussed were weather conditions in winter, roadway limitations, lack of bike lanes along much of the route, lack of law enforcement, no or

poor cell phone communication in much of the area and possibility of auto/bike collisions. It was noted that other scenic bikeways have similar issues. Mike Chaveas reported that he had researched traffic records of the MT Hood National Forest and found no records of any reports of collisions between bikes and autos in the last 20 years. He also indicated that their measures indicated the level of traffic was relatively low with peak use on weekends and late summer.



The Detroit Ranger District of the Willamette National Forest supports the designation of the Detroit Lake/Estacada Two Rivers Pedal as a State Scenic Bikeway that crosses the forest on Forest Road 46. My district staff is available to assist the committee in the development of management and marketing plans for this route. Increased cycling opportunities in the Breitenbush River corridor could help the local economies of Detroit, Estacada and surrounding communities that are interested in expanding and diversifying tourism and recreation opportunities.

Based on the Oregon Bike Pedestrian Design Guide bike lane separation matrix, a shared roadway configuration is appropriate with an average daily traffic of 1500 or less. Currently, Road 46 has less than 1500 vehicles per day. We would like to provide input on Scenic Bikeway route sign locations and additional safety signing for vehicles. I feel it is important to let riders know that Forest Road 46 has no designated bike lanes and could likely have debris, pot holes and other conditions that can affect bike safety. We advise the posting of "Bicyclists on Roadway" signs to remind vehicles that may not be expecting them on a remote Forest road. Due to our limited budgets, we cannot commit to increased road maintenance as a result of this designation. Additionally, designation of this route as a Scenic Bikeway would not preclude or supersede any other management actions or options along the route on the part of the National Forest.

### Oregon Scenic Bikeway designation for Detroit Lake

Commissioner Milne explained that in 2011 the Detroit Lake Recreation Area Business Association (DLRABA) submitted an application to the Oregon Parks and Recreation Department's (OPRD) Scenic Bikeway Program and at the beginning of the process she had signed a letter of general support. She said the Scenic Bikeways Advisory Committee has evaluated the proposed 72 mile route and given its approval for the Two Rivers Pedal Bikeway to proceed to the next phase of the application process. She said DLRABA is now requesting a letter of support stating that the county would like to see DLRABA continue with the application process.

Commissioner Milne described the proposed bikeways route that would travel from Detroit to Estacada. She said the bikeway route begins in the City of Detroit, crosses Highway 22, and travels onto a US Forest Service road. None of the roads on the bikeway route belong to Marion County and therefore Marion County will not be financially responsible for the road maintenance. Commissioner Milne said the proposed bikeway promotes economic development, offers a new recreational opportunity, and would be beneficial to both communities. She would like the board to send a letter of support.

Commissioner Brentano explained why he does not support the proposed bikeway. He said he is concerned that bikes conflict with motorized transportation and questions about public safety have not been addressed. He said there may be commercial activity (logging) on the forest road, the road may not be wide enough, and there are no regular patrols. Commissioner Brentano said he understands the road is not maintained by Marion County, but he has the same safety concerns for any road in Oregon and added that he would need to know what would happen if someone was injured on the route. He said he also has concerns about amenities. He has not seen anything about restrooms or telephones that would be available to the bikers along the route.

Commissioner Brentano said if DLRABA would like his support he would need a description of the forest road, including width and capacity, and how many vehicles use the road. He would also need information on the type of amenities and safety plans that would be in place. Commissioner Carlson said Commissioner Brentano expressed these same concerns at a meeting in Mill City. She said she would be happy to sign a letter of support.

Commissioner Milne said she understands Commissioner Brentano's position on road funds being diverted to support bikeways and she agrees, but in this case the proposed bikeway is funded through OPRD and other separate funding. It is not funding from road jurisdictions. She said the proposed bikeway has to do with economic development and a new recreational opportunity and there will be no burden on the county. Commissioner Milne said Commissioner Brentano has legitimate concerns and she will investigate and get answers for him. There was a short discussion on the OPRD grant funding. Commissioner Milne will also provide specifics on the proposed bikeway's funding. Don Russo, economic development manager, will draft a letter of support.

After MP 49.66, the route becomes (Forest Service) Rd 46.

The Oregon Bicycle and Pedestrian Design Guide indicate on pages 1-5:

"Shared roadways are suitable in urban areas on streets with low motor vehicle speeds or traffic volumes, and on low volume rural roads and highways. The suitability of a shared roadway decreases as motor vehicle traffic speeds and volumes increase, especially on rural roads with poor sight distance. See Bike Lane Matrix for suitably of shared roadways based on motor vehicle speeds, volume and context."

An examination of the Bike Lane Matrix indicates that a shared roadway configuration is appropriate with an ADT of 1500 or less even at higher speeds. This is the scenario for most of the State Highway included in the bikeway without a 4 foot wide shoulder. The exception is inside the City of Estacada where the traffic volumes are higher, but with the lower speeds, the matrix indicates that a shared route is still appropriate.

Based on this analysis, the proposed shared lane bikeway configuration conforms to ODOT standards per the Oregon Bicycle and Pedestrian Design Guide. Since this bikeway meets this standard, we reiterate our full support for this project.

Should this route be chosen we will continue to offer support and/or input to the local proponent in the development of the Scenic Bikeway Management Plan. If you have any questions, please contact me at (503) 731-8218.

As the Region 2 Traffic Engineer I have reviewed the proposed Estacada to Detroit Scenic Bikeway which crosses at OR 22 (Hwy 162) and Forest Avenue. The existing intersection currently is marked with a standard crosswalk bars. We have a new approval on file for an improved crossing on the north leg with staggered continental markings and a Rectangular Rapid Flashing Beacon. This is to be installed as funding is found and the City of Detroit acts upon an IGA for maintenance and operations. I can support the use of this crossing as part of the scenic bikeway. If this route is to be chosen we will offer support and/or input in the development of the Scenic Bikeway Management Plan contingent on installation of the staggered continental markings and the Rectangular Rapid Flashing Beacon at the intersection.
