

### **Bikeway Description**

300 words or less

For those looking for a challenge and great wildlife viewing, the 90-mile <u>Oregon Outback Scenic Bikeway</u> will not disappoint.

The Bikeway begins and ends in the vibrant small town of Lakeview in far south central Oregon. Cyclists can find food, lodging, and all supplies needed before embarking on the ride.

The Bikeway is nestled in the beautiful north Warner Mountains, experience the forest/desert fringe with expansive views of Drake Peak, the Coyote Hills, Fish Creek Rim, upper Warner Valley, Hart Mountain Antelope Refuge, Warner Peak, and Poker Jim Ridge. Keep an eye out as well for pronghorn antelope and sage grouse. Put your head down and rip down 1,300 ft. descent into the desert outpost of Plush, ride rolling lakeshores to Adel along Fish Creek Rim Wilderness Study area and the wetland lakes of the Warner Valley including: Hart Lake, Priday Reservoir, Crump Lake and the Narrows. Enjoy views of Pelican, Crump, and Hart Lakes, and of course the spectacular escarpment of Hart Mountain National Antelope Refuge. Keep an eye out for wetland birds and bighorn sheep!

Be sure to stop for a memorable ride photo at Deep Creek Falls. While in the canyon, look for cliff swallows, golden & bald eagles, red tail hawks and falcons. Departing from Camas Snow Park, head west, up and over Warner Pass and watch the trees whiz by in a blur as you scream down the pass for one last thrill ride as you coast back into Lakeview.

The Oregon Parks and Recreation Department will host a public meeting for a proposed Oregon Scenic Bikeway at 5:30 p.m. Wednesday, March 30 at the Lake County Memorial Hall, 513 Center St., Lakeview, according to a news release.

The proposed 90-milelong Outback Scenic Bikeway uses existing roads and passes by the towns of Lakeview, Plush and Adele. The Bikeway offers expansive views of Drake Peak, the Coyote Hills, Fish Creek Rim, Hart Mountain Antelope Refuge and Warner Peak as well as pronghorn antelope, big horn sheep and sage grouse.
