The Office of Research, Evaluation and Strategic Policy Development of the Pennsylvania Commission on Crime and Delinquency (PCCD) announces the availability of School Safety and Security Program funding to support School Mental Health & Safety and Security Grants for the 2022-2023 school year. School entities (i.e., school districts, area career and technical schools, intermediate units, charter schools, regional charter schools and cyber charter schools) are immediately eligible to apply for these funds to address mental health initiatives and physical security enhancements.

Per Act 55 of 2022, \$190 million is being announced to support this initiative: \$95 million of which is dedicated to mental health initiatives and \$95 million dedicated to physical security enhancements. Awards will be made to 784 eligible school entities with budgets not to exceed the formula distribution included in the solicitation for 24-month project periods, contingent on the school entity making application to PCCD.

- <u>Due Date</u> Applications must be submitted electronically through PCCD's Egrants system no later than 11:59 PM on Wednesday, August 31, 2022.
- **Technical Assistance** Grant application and administrative guides can be accessed on <u>PCCD's Website</u> under the Funding section. Applicants are strongly encouraged to review the application and administrative guides before calling the Egrants Help Desk for assistance. - <u>Egrants Submission</u> An application submitted in Egrants by the deadline is not considered complete until PCCD has received the original signature page, as well as any other required documents.
- **Administrative Rejection** An application that does not meet all the listed requirements in this funding announcement may be administratively rejected.
- **Corrections** If PCCD returns an application for corrections, the final application (including all corrections and required documents) must be returned to and approved by PCCD for the requested funding to be awarded.
- **Non-supplantation** Funding must not be used to supplant/replace state, federal or local funds that would otherwise be available to provide for program-related services. PCCD funding is to be used in addition to other funds that are made available for services.
- **Keywords** Applicants are required to select "Keywords" from the dropdown menu located on the Main Summary screen in Egrants. The required keywords are below. Applicants may also select other keywords that apply specifically to their application.

PENNSYLVANIA COMMISSION ON CRIME AND DELINQUENCY School Safety and Security Committee (SSSC)

1. Overview:

The Pennsylvania Commission on Crime and Delinquency (PCCD) is now accepting applications for funding under the School Safety and Security Program Grant Fund. Per the passage of <u>Act 55 of 2022</u>, the primary purpose of 2022-23 School Mental Health & Safety and Security solicitation is to provide grants to eligible school entities to support both mental health initiatives and physical school security enhancements.

The objective of the FY 2022-23 School Safety and Security Grant Program is to ensure that eligible school entities meet 'Tier 1' of the Baseline Criteria Guidance for Physical Security, Behavioral Health and School Climate developed by the School Safety and Security Committee (SSSC) and adopted in February 2021. These Baseline Criteria were developed to organize safety and security-related equipment, trainings, policies, programs and activities into a tiered structure (i.e., from Tier 1, which includes the most basic physical and behavioral health safety elements, to Tier 3, which includes the most comprehensive elements). These tiered guides serve as a resource a school entity should reference to determine their level of need and identify areas for further improvement. The overarching goal of the School Safety and Security Grant Program is to improve the safety and well-being of Pennsylvania's students through investments in physical security, behavioral and mental health, and school climate approaches.

School entities are strongly encouraged to review these <u>Baseline Criteria</u> in advance of submitting your grant application under this solicitation to determine what criteria your school entity currently meets and where additional investments may be needed. Tier 1 criteria must be satisfied prior to school entities utilizing these resources for other Eligible Program Activities and Expenses (see page 5).

2. Funding Availability:

A total of \$190 million in funds provided through <u>Act 55 of 2022</u> is being announced to support this initiative: \$95 million of which is dedicated to mental health initiatives and \$95 million dedicated to physical security enhancements. Funding is based on the formula included in Act 55, which stipulates school districts are to receive a \$100,000 base amount for mental health and a \$100,000 base amount for physical health initiatives (\$200,000 minimum total), and an additional amount based on their 2020-21 Average Daily Membership (ADM). All other eligible school entities (i.e., intermediate units, area career and technical centers, charter schools, regional charter schools and cyber charter schools) are to receive \$70,000 for mental health activities and \$70,000 for physical security enhancements (\$140,000 total).

PCCD expects to fund 784 grants with budgets not to exceed the funding allocations as detailed in Appendix A starting on page 19.

Award letters will be available in Egrants as soon as possible after the applications are approved.

PCCD is not liable for costs incurred prior to the official start date of the award.

3. Project Dates:

As these are noncompetitive funds, applications will be approved by PCCD staff as they meet the criteria of this solicitation for 24-month projects and will have a general start date of August 1, 2022 and an end date of July 31, 2024. Actual project dates may vary dependent upon timeliness of the application submitted, the length of PCCD staff review, and the responsiveness of the applicant to staff inquiries; however, all projects will be for a period of 24 months. Please be cognizant that any expenditures made prior to the official award notice from PCCD may be deemed ineligible during the application review.

4. Eligible Applicants:

Per Act 55, eligibility of these funds is open to School Districts, Intermediate Units, Area Career and Technical Schools, Charter Schools, Regional Charter Schools, and Cyber Charter Schools. All eligible applicants and the amount eligible to apply for can be found in Appendix A of this solicitation.

5. Eligible Program Activities and Expenses:

Funds can be used to support the following items or activities included in 24 P.S. §13-1306-B(j)(1-30) as amended by Act 55 and as required by Sections 1314-B and 1315-B of the Public School Code. Please see the information below for details on these eligible activities and expenses.

5a. Physical School Safety and Security Grants for 2022-23 School Year Eligible **Activities and Expenses**

A school entity shall be eligible to utilize their physical school safety and security grant to meet the Tier 1 Baseline Criteria for physical security established by the SSSC (see Application Procedures section on page 9 for more on this standard). If a school entity does NOT meet all Tier 1 Baseline Criteria for physical security, they should utilize their grant on one or more of the available activities below to meet the Tier 1 standard or explain to PCCD how other resources are being utilized to satisfy the criteria.

Once, or if, a school entity has met the Tier 1 Baseline Criteria for physical security, they are eligible to use funding to support any, all or one of the following items or activities outlined in Section 1306-B(j):

- "(j) Specific purposes.--The committee shall provide grants to school entities for programs that address safety and security, including:
- 1) Safety and security assessments that meet the committee's criteria.
- 2) Conflict resolution or dispute management, including restorative justice strategies.
- 3) School-wide positive behavior support that includes primary or universal, secondary and tertiary supports and interventions in school entities.
- 4) School-based diversion programs.
- 5) Peer helper programs.
- 6) ***1

7) Classroom management.

8) Student codes of conduct.

¹ Please note that activity/program categories with a "***" within the physical security section refer to activities/programs that have been identified in Act 55 as mental health-related. Those activities/programs are included and allowed under the School Mental Health Grants section 5b.

- 9) Training to undertake a districtwide assessment of risk factors that increase the likelihood of problem behaviors among students.
- 10)***
- 11) Thorough, districtwide school safety, violence prevention, emergency preparedness and all-hazards plans, including revisions or updates to such plans and conducting emergency preparedness drills and related activities with local emergency responders.
- 12) Security planning and purchase of security-related technology, which may include metal detectors, protective lighting, specialty trained canines, surveillance equipment, special emergency communications equipment, automated external defibrillators, electronic locksets, deadbolts, trauma kits and theft control devices and training in the use of security-related technology. Security planning and purchase of security-related technology shall be based on safety needs identified by the school entity's board of school directors.
- 13)Institution of student, staff and visitor identification systems, including criminal background check software.
- 14) Provision of specialized staff and student training programs, including training for student assistance program team members in the referral of students at risk of violent behavior to appropriate community-based services and behavioral health services and training related to prevention and early intervention.
- 15)***
- 16) A system for the management of student discipline, including misconduct and criminal offenses.
- 17)***
- 18) Costs associated with the training and compensation of school resource officers and school police officers.

- 22) Programs designed to reduce community violence, including:
 - (i) Increasing access to quality trauma-informed support services and behavioral health care by linking the community with local trauma support and behavioral health systems.
 - (ii) Providing health services and intervention strategies by coordinating the services provided by eligible applicants and coordinated care organizations, public health entities, nonprofit youth service providers and community-based organizations.
 - (iii) Providing mentoring and other intervention models to children and their families who have experienced trauma or are at risk of experiencing trauma, including those who are low-income, homeless, in foster care, involved in the criminal justice system, unemployed, experiencing a mental illness or substance abuse disorder or not enrolled in or at risk of dropping out of an educational institution.
 - (iv) Fostering and promoting communication between the school entity, community and law enforcement.
 - (v) Any other program or model designed to reduce community violence and approved by the committee.
- 23) The implementation of Article XIII-E (relating to Threat Assessment)."

<u>5b. School Mental Health Grants for 2022-23 School Year Eligible Activities and Expenses</u>

Per Act 55, a school entity is eligible to utilize their mental health grant to meet the Tier 1 Baseline Criteria for behavioral health and school climate established by the SSSC (see Application Procedures section on page 9 for more on this standard). If a school entity does NOT meet all Tier 1 Baseline Criteria for behavioral health and school climate, they

should utilize their grant on one or more of the available activities below to meet the Tier 1 standard or explain to PCCD how other resources are being utilized to satisfy the criteria.

Once, or if, a school entity has met the Tier 1 Baseline Criteria for behavioral health and school climate, they shall be eligible to use funding to support any, all or one of the following items or activities outlines in Section 1306-B(j):

- "(j) Specific purposes.--The committee shall provide grants to school entities for programs that address safety and security, including:

- workers, school psychologists and other professional health personnel to provide services to students and school employees.
- B. Developing collaborative efforts between the school entity and behavioral health professionals to identify students in need of trauma support and to provide prevention, screening, referral and treatment services to students potentially in need of services.
- C. Partnering with community-based organizations for peer or family support.
- D. Training on youth-focused mental health first aid for school employees to help recognize signs of mental health distress in students.
- E. Providing activities to improve mental health in a school entity and after school programming.

ii. Programs providing:

- A. Trauma-informed approaches to education in the curriculum, including training of school employees, school directors and behavioral health professionals to develop safe, stable and nurturing learning environments that prevent and mitigate the effects of trauma.
- B. Services for children and their families, as appropriate, who have experienced or are at risk of experiencing trauma, including those who are low-income, homeless, involved in the child welfare system or involved in the juvenile justice system.

23) The implementation of Article XIII-E (relating to Threat Assessment).3

- 30)Providing online programs, educational materials and applications to provide supplemental mental health services to students that may include peer support, self-guided evidenced based therapeutic tools and clinical interactions."

All expenses must be described in the Justification box located in the Egrants Budget Detail section. Please note that PCCD has approval of all final budgets. Also, per Act 55, the SSSC shall randomly audit and monitor grant recipients to ensure the appropriate use of grant funds and compliance with provisions of the grant program, which includes satisfying Tier 1 criteria.

³ Please note that category (j)(23), threat assessment, is an allowable expenditure in both the physical school safety and security grant section or mental health grant section.

6. Ineligible Program Activities and Expenses:

Eligibility of items or activities may be dependent on whether the applicant meets 'Tier 1' of the <u>Baseline Criteria Guidance</u> for Physical security, Behavioral Health and School Climate developed by the SSSC. Applicants are also limited to selecting appropriate, eligible activities as allowed for by Act 55 if they already meet Tier 1 criteria.

Any item or activity not included in 24 P.S. §13-1306-B(j)(1-30) may be deemed ineligible. The SSSC has also previously determined that retractable safety batons for classroom staff, "Framework for Understanding Poverty" book and workbooks, tactical handcuffs and nylon restraints, and school safety hotlines are ineligible expenses.

Please note that Act 55 also placed a requirement on the SSSC to develop training standards for school employees to meet the requirements of Section 1310-B (related to school safety and security training) and training criteria for Section 1309-B (related to school safety and security coordinators). \$4.8 million in funding was set aside to provide for this training, which will be provided free of charge to school entities once developed and approved by the SSSC during the 2022-23 school year. While school entities are not prohibited for applying for these types of training, PCCD and the SSSC strongly encourage school entities to take this upcoming training into consideration in determining which activities to make application for.

7. Required Egrants Sections/Documents:

- a. <u>Required Egrants Sections</u> All sections identified in Egrants are required. Applicants will not be able to submit their grant application in Egrants until all sections are marked as complete.
- b. Required Signed Documents A successful application must be accompanied by the following:
 - The executed Signature Page (page 2 of the application) see Submission Information section on page 18 of this document.
 - If applying for any item under 24 P.S. §13-1306-B(j)(12) also known as 'Category 12' school entities must attach documentation from their school board or board of directors demonstrating that the request for purchases related to security planning and the purchase of security-related technology is based on safety needs identified by the board. Types of acceptable documentation may include one of the following: a letter of support, a board resolution, or meeting minutes of the board or a subcommittee of the board discussing and/or approving the request for the item to address a safety need. This documentation should be attached to the application in Egrants.

8. Application Procedures:

Applicants must submit the requested information for each section specified below within the defined response fields provided in Egrants. Responses should not be duplicated in multiple sections.

b. Mental Health Survey

Act 55 created a new Section 1305.1-B (relating to survey of school mental health services) which required the SSSC to develop and distribute a survey instrument to measure mental health services throughout school entities in the Commonwealth. All data collected through the survey shall remain confidential and exempt from access under the Right-to-Know Law.

The following questions satisfy the School Mental Health Services Survey and are incorporated into the School Safety and Security Grant application for FY22-23. School entities will have until August 31, 2022 to submit their survey and grant application.
