- In the goals section, under inclusive participation, an extensive list of groups is provided. Should the county consider engaging with low-income, cost burdened, and/or houseless demographics as these are now required Housing elements?
- This list of community partners and interest parties is inclusive, but very general. Will specific key stakeholders be identified and communicated in the PPP engagement mediums?
- The project webpage link provided in the PPP, under the public participation tools section, does not work.
- Will news releases and email notifications be provided in multiple languages or with a link or reference to find these translated documents?
- Will public engagement also include postings throughout the Clark County government buildings? During the work week, several residents, community partners, and interest parties visit County buildings and could be considered as another engagement tool.
- Under the engagement tools section, it states that planning commission and county council meeting notices "could" be provided through listed methods. It is not a direct action and does not provide public certainty where to find this information.
- Will there be opportunities for public engagement (other than PC or County Council work sessions/hearings) in early phases of the update process? Open houses and public comment on draft documents are later in the process and may be too late for formative public engagement opportunities, such as engaging the public prior to drafting policies to have better guided and more inclusive policy making.

At first look, the Public Participation Plan that county staff has outlined looks to check all of the appropriate boxes for a good communication plan.

But I have concerns about how effective efforts to communicate details about the update truly will be for the more than half a million people who call Clark County home. Furthermore, I have concerns about whether the efforts will prompt meaningful engagement by our residents.

Consider these points:

Although the audience list is lengthy and includes stakeholders from a wide variety of the population, the number of recipients who will be notified of meetings and other information is only over 1,000.

The project webpage is not currently operative.

The plan notes the county will keep people informed via its social media accounts, but I saw only one mention on Facebook about the request for comments on the Public Participation Plan. And there were no likes or comments on the post. The county's Twitter account featured one Tweet about the PPP, and it had been viewed 229 times.

To rely heavily on local media to communicate a great deal about the update is to ask a lot of local media, which is already spread thin. I salute the Columbian which did feature a news brief about the opportunity to comment on the Public Participation Plan. But the only reason I knew about the opportunity was because I was urged to do so by a friend.

My point is that people need people they know and trust to make them take action.

As for engaging or involving residents, I question how many of the parents whose young children need them to drive them to soccer practice, attend parent-teacher conferences, provide homework help and perhaps work a second job to make ends meet, will be able to attend open houses or public hearings. Yet, this plan to determine Clark County's next 20 years will impact those young children more than it will impact many of you and certainly me.

I propose that the outreach and engagement efforts be more focused and personal. County staff and the staffs of the seven municipalities are limited. But they could strive to meet people where they are? Could

they set up tables at the farmer's markets? Have booths are the Clark County fair? Hold workshops at schools where teen-agers can learn about plans to create the future they will inherit? Make personal appeals to members of community groups to explain the significance of the plan?

Furthermore, elected officials at the county level and in each municipality need to reach out to their constituents and groups to inform them of the significance of the update. Wouldn't it be reasonable for them to do as much outreach and campaigning to explain the update to the public that they do to get elected? After all, aren't the people who elected these officials the ones they should serve?

Clark County Citizens United, Inc. has reviewed the proposed **Public Participation Draft**, but not in great depth. As you may know, we have seen many of these proposals, in some form, over the approximately 30 years that CCCU has been involved with the land use processes. They all look a little different. This Draft is probably the best one we have seen so far, so CCCU has hope that things will go differently, this Comp Plan cycle.

The 2016 public process was pathetic, to say the least. The first scoping meeting, many people from the public attended. But they quickly learned the Plan was already

written, and they only fulfilled a meeting date. One land owner asked the staff why his land is zoned 20 acre ag, when he and his neighbors had 2.5 acre zoning in the past. He said his neighbors have the smaller lots, but his is the only big one, because he didn't divide it. Staff stopped him mid-sentence and said they were not there to discuss his concerns. He insisted he wanted answers. Staff continued to silence him.

The whole meeting was alarming, and CCCU saw just what that man saw, we were only filling chairs. What the public had to say, meant nothing, because the Plan was already decided. We were able to prove the Plan had already been written by the year 2012, via staff emails, before the 2014 Public Participation Draft was adopted. Hopefully that will not be the case, again.

CCCU has noted a few paragraphs of the current Draft to make comments on.

The Comprehensive Plan guides county decisions related to land use; housing; capital facilities and utilities; rural and natural resources; transportation; economic development; parks, open space and recreation; schools; historic preservation; environment; community design; shoreline; and annexation.

CCCU assumes this paragraph comes from the Growth Management Act dictations as to what should be considered. The GMA has 14 Planning Goals that are mandated. They hold EQUAL standing, yet the protection of private property rights goal has been ignored, since 1994. It is time that goal is given equal standing with all of the other Goals. CCCU has highlighted what we believe to be the most important goals to be considered in this Plan update. Because these goals have not been properly addressed, these items are in critical shortage.

RURAL - LAND USE - HOUSING - Historically, the ratio of urban housing to rural housing was always 80/20. This allowed for a balance of development and the ability for cities to keep up with growth. This ratio was adopted in 1994. But in 2004, it was changed to 90/10, for no other reason than the county did not want people to live in the rural areas, as before. The ratio was changed to force people to live in the urban area, regardless of their choice or preference. Today that number is 99/1. This is a total failure of the housing ratio adopted in the 2016 Comprehensive Plan. Rural land must be up-zoned to restore the balance that had worked so well in the past.

ECONOMIC DEVELOPMENT - This county now has the opportunity to truly plan it's economic future, with the inclusion of the short line railroad development, allowed in the GMA. With that new language, the whole county can provide and enjoy economic growth and freedom, both urban and rural. The railroad travels diagonally through the county, in the same location of many past and current communities. It was used for jobs and travel and it can do that again. It is exciting to think of the economic possibilities, once the railroad is updated. CCCU hopes to see this come to fruition.

Collect individual property owner proposals for comprehensive plan amendments for consideration through the lens of the chosen growth alternatives

CCCU believes this passage is concerning. The highlighted area says that there are already chosen growth alternatives. In the 2016 update, the alternatives were indeed pre-chosen, to be a no growth agenda. The county and cities are grappling with that poor planning goal today. All alternatives need to show that growth will be allowed to increase throughout the county. Staff should first determine what the public market wants and needs, and write alternatives that reflect that growth potential. Alternative 4 was an excellent example of planning for growth in the right way, and should be reconsidered again, in this update.

Elected to four-year terms, members of the Clark County Council hold legislative authority for Clark County. Related to the comprehensive plan update, the council is the ultimate decision maker and responsible for adopting the Comprehensive Plan and related development regulations

These highlighted words make a profound statement. In the past, the commissioners/councilors simply left it up to staff to dictate planning, assuming they know best. But, the result of that planning has been failure in rural, land use, housing and economic development. As the years went by we saw higher rent, higher taxes, higher housing costs, higher county unemployment, and higher homelessness, which is a direct consequence of the other items and the poor planning that created it. The county must do things differently in this update, than what was done in the past. Staff and the Planning Commission are only advisory. It is up to this council to fix the problems that are plaguing this county, and a total focus on environmental issues is not the right answer. It doesn't work, and Clark County citizens must have change.

RE: City of Vancouver Comments on the draft Clark County Comprehensive Plan Update Public Participation Plan (PPP)

Thank you for the opportunity to comment on the draft County PPP, and to attend the informative public kick-off meeting held on January 19. The PPP establishes the scope of the Comprehensive Plan update and the timing of actions, as well as ways for the public to participate. We appreciate the draft's succinctness, its well-articulated goals, and the various listening opportunities it provides. Our comments here are focused primarily on ensuring that needed information is available for meaningful and informed participation by the public and stakeholders, and ultimately for decision-makers.

We would respectfully recommend adding the following to the draft PPP and subsequent process:

- 1. Include an informational meeting with Office of Financial Management (OFM) forecasters before adopting a local Countywide Population forecast. This important choice which drives the regional planning process is proposed to be made more quickly than in prior updates, and with only one public hearing. The stakes from this are significant, as the state's medium and most likely forecast would mean increasing countywide population by roughly 175,000 people from now until 2045, almost the equivalent of adding another City of Vancouver. Since the state provides the allowed range of forecasts to choose from, the public, stakeholders and decision makers would benefit by being able to hear directly from OFM staff about how their forecasts were created, what factors they do and don't consider, and how accurate prior forecasts have been, before the local adoption choice is made. Vancouver would be happy to assist in facilitating an in-person or virtual meeting, or host one ourselves. OFM staff have indicated they are willing to participate.
- 2. Include an informational meeting with Department of Commerce staff on recently adopted housing requirements. Under new HB 1220, cities and counties are now required to plan for and accommodate set numbers of housing units in various affordability ranges, including emergency housing, based on the overall population targets chosen. These numbers are also big. For example, if Clark County selects the OFM medium countywide forecast, local jurisdictions would together need to plan for and accommodate roughly 36,000 housing units affordable to those earning 50% of Area Median Income, another 16,000 units affordable at 80% AMI, and emergency housing for 3,400 persons. Depending on how countywide growth is allocated locally and other factors, it appears the unincorporated Vancouver UGA might face a third of this burden, or more. An informational meeting with DOC staff could provide local public, stakeholders, staff, and decision makers a shared understanding of what these requirements entail. Whatever the technical outcomes of the HB 1220 requirements or other bills now being consider by the legislature, housing requirements for local

governments are likely to be considerably more far reaching than ever before, and informing all parties, particularly the pubic, sooner rather than later in the process is, in our view, key to a successful plan update process. We are also happy to assist in facilitating this meeting, which potentially could be combined with the first meeting listed, or host it ourselves.

- 3. Address the buildable lands model before issuing the Draft Environmental Impact Statement, not after. Growth data shows that the current buildable lands model significantly underestimates actual residential growth capacity. Using it in the EIS may effectively mislead the commenting public, as well as decision makers, by mistakenly estimating that various land use scenarios will result in significantly less population growth and cost less to serve than is likely to occur in practice if they are adopted. The current model was adopted in 2022 to estimate whether there was or was not sufficient existing land as part of the Buildable Land Report, not to size new UGA boundaries, which is more practically and legally challenging. More importantly the current model was adopted following a review of individual input assumptions in isolation, with no testing of the overall model results against actual population growth to determine the model's overall accuracy, and little to no response when the model's results were then shown to be inaccurate in the face of growth and development data. We also understand the new HB 1220 housing requirements will effectively require revisiting some aspects of the model. This issue needs to be resolved so there are reasonably accurate model results to plan the region's future growth and capital facilities, and to engage the community.
- 4. Describe County and City roles consistent with state and local policy direction. The draft's PPP's page 10 summary gives no indication of how GMA and longstanding locally adopted policies temper county final decision-making authority, or that cities have any role outside their existing boundaries. The GMA requires counties to attempt to reach agreement with cities regarding UGAs and justify their position in writing if agreement can't be reached, with the Department of Commerce attempting to resolve formal objections where appropriate (RCW 36.70A.110). UGA review should be conducted jointly including consultation with cities, with the result reflecting a cooperative effort. Procedurally, cities should first propose the location of UGAs (WAC 365-196-310). Local Countywide Planning Policies go further, calling for cities and counties to play partnership roles in the production of plans which provide the opportunity for public and mutual participation, review, and comment including "joint hearings within the urban growth areas" (CPP 1.1.12 and 1.1.13, page 42 of County Comprehensive Plan). A summary of the required collaboration and coordination would be helpful for a shared general understanding by all parties, including the public. A mention of the City role in first proposing UGAs would indicate to property owners or others proposing expansions where they should inquire first. A mention of how the Comprehensive Plan update impacts annexation could also be useful in answering public questions.
- 5. Indicate how the draft's Goal 2 for inclusive participation will be met. We appreciate the PPP's efforts to prioritize engagement with those historically left out of planning processes and have elevated equity goals in our own Comprehensive Plan update process now underway. Every jurisdiction is different, but we would just suggest the PPP include some indications of how the communities cited will be engaged and their input used. Our interest here is strongest in the Vancouver UGA for those communities anticipated to annexed to the City at some point in the future, but the issue applies throughout.

6. Include information about long term implications of current Comprehensive Plan update decisions beyond 20 years, per state law. 20-year Comprehensive Plans, growth forecasts and UGAs are required to be reviewed and updated at least every 10 years. WAC 365-196-310(4)(C)(II) and (III) requires that when considering UGAs and forecasts, counties and cities consider the timing of future updates, opportunities for adjustments, and where longer-term land supply limitations exist, the extent to which current forecast options would require increased densities or slower growth in the future. WAC 197-11-440(5)(c)(vii) requires EIS analyses to consider "benefits and disadvantages of reserving for some future time the implementation of the proposal, as compared with possible approval at this time. The agency perspective should be that each generation is, in effect, a trustee of the environment for succeeding generations. Particular attention should be given to the possibility of foreclosing future options by implementing the proposal." Clark County has a finite amount of land that can be urbanized, particularly since there is a great deal of sloped and forested land in the northern and eastern portions of the County that may never be suitable for intense development. Decisions made in this update will influence how soon farm and rural lands are depleted, and how soon the rate of growth will be forced to slow because there are no further areas in the County to expand into. For informed community participation, we recommend the County provides a forum for discussion about the desired longer-term future, or at minimum an indication of what would happen if the growth options presented in this update cycle are continued on into the future.

Thank you again for the opportunity to comment on the PPP. We look forward to working with you on the upcoming Comprehensive Plan update, and welcome your input on our process within the City of Vancouver.

In total, the draft plan for public participation looks to be quite comprehensive. The addition of providing interpretation and making a concerted effort to reach audiences who may not have been involved with governmental decision-making in the past, is laudable.

One audience that I wish got more than a one-word mention in the ten page plan is our youth. That's who we're really doing planning for. What types of jobs, housing, natural spaces, even dog parks, would they want to find here when they start adulting in a few years? The county has a Youth Commission with representation from throughout the county. Perhaps they could help with distributing surveys on livability to those in their schools, communities and social media. You could also encourage *families* to attend open houses and other public meetings together and provide a means of collecting input from the younger set.

Producing information is the easy part. Engagement, as busy as people are these days,

is difficult. The Comp Plan is big, complex, and full of acronyms and government-speak and that complexity makes it difficult for people to recognize that the plan, and the changes being proposed, could significantly impact them and their children. As a result, they don't realize they should be involved or, if they do, their involvement comes too late.

The more the big pieces are broken down and delivered where residents are, the better. I see a lot of chatter on NextDoor and believe that is a good means of reaching people. Expecting busy people to come to the county's website, show up at a meeting or even access the county's social media, is not going to be adequate. Quick and easy surveys are a great tool.

Neighborhood Associations should play a big role. Special meetings to brief the NA presidents and help them understand their importance in reaching out to their members at key intervals could be very valuable. Some presidents do a better job than others in communicating. Even though my NA has been "disassociated" by the county, our former president sent out the information about commenting on the draft PPP. A special invitation to all NA presidents to attend an online briefing could help to engage them. The presentation Oliver gave to the Planning Commission would be perfect.

You're not going to get half a million residents to participate but I certainly hope that more than the "hundreds" that Ms. Cook proudly mentioned (in the meeting on January 19) will contribute their ideas and thoughts.



Friends of Clark County (FOCC) is pleased to submit comments to Community Planning on its recently released draft of a Public Participation Plan as one of the first steps in the Comprehensive Plan Update. Public participation is a critical piece of governing, and in particular, during major updates, such as this, that will determine how Clark County manages its growth well into the future.

For the last 25 years, FOCC has been committed to participating in county processes that impact quality of life and economic health for all its citizens. We (FOCC) always appreciate the opportunity to provide feedback.

Overall, the Draft PPP is comprehensive, effectively laying out the scope of the Comprehensive Plan Update, with estimated timeframes and due dates clearly stated.

However, although the intent is to be admired, there is little in this plan that hasn't been done or tried in the past and so it remains business as usual. That approaches used in the past have been successful is a misconception on the County's part.

We live in a period of increasing pessimism in our government at all levels, as well as in those that govern. A plan which lays out a roadmap of public participation has the opportunity to put into practice ways to build faith in governance among all segments of its population, including those – and especially those - who are the most marginalized.

Therefore, our expectation is that Clark County not only intends to reach the public but GUARANTEES accessibility and participation of all; and that the County makes a greater and more aggressive effort to go to the public, as opposed to expecting the public to come to it.

Our recommendations:

Enforce processes and apply them equally to all – including those who consider themselves "entitled" and able to get "inside" Staff and elected officials. This includes



the 3-minute time limit at public hearings: equitably extend time allowances as opposed to extending for some (such as attorneys), not for others. Consider developing a flexible plan for hearing organized groups that enables messages to be communicated but limits time for each speaker to less than 3 minutes.

- Reach the public in ways that meet the public's lives:
 - o Implement much greater notification periods than 14 days, especially notifications regarding major changes to a local neighborhood, such as mining projects, railroad changes, large-parcel rezones. Once word reaches a community, it takes weeks to gather neighbors together, investigate, find resources that will support its opinions, rearrange people's schedules in order to meet with Staff or Councilor. Preparing for a public hearing in front of a Planning Commission or County Council is not easy for a group of individuals who have never done it before, have work schedules to juggle, baby sitters to find, or can't afford to sit in a Council chamber for 2 to 3 hours.
 - Acknowledge and reach a broader radius of residences when considering a land-use decision that heavily impacts a community; 500 ft is not a significant distance in rural areas of our lovely county;
 - Use the public school system for reaching families regarding pending land-use issues;
 - Provide more open houses in particular in rural areas, at different times of the day;
 - Use larger and more prevalent signage; place in areas where traffic is not affected.
 - Increase press releases and publish in as many news media as appropriate.
 - Collect input from the public and measure that input against how that input impacted the final decision: comparing what was asked of the public with a final decision. Make sure that we, the public, are aware of our own strength as it

impacts decisions that Staff and Elected Officials make. We hear from a Councilor that "we heard from the public....", but we would benefit from knowing just how our input was used in making a final decision.

We envision a transparent county government that empowers its communities, all members of those communities, those who are demanding the right to participate as partners at every level. We envision a government that can guarantee putting practices in place that result in an engaged, enlightened, energized and positive group of committed citizens.

We look forward to a productive and successful future.
