
















The Comprehensive Plan

- Originally adopted in 1994 and last updated in 2016
- Plan is a long-range policy guide to manage growth and development over a 20-year period
- Growth Management Act (<u>RCW 36.70A.130</u>) requires jurisdictions to periodically review and update, if necessary, their Plan and development regulations to bring them up to date with:
 - Changes to state law,
 - Land use changes, if any,
 - Population and employment growth projections, and
 - Housing projections








Planning in Clark County

The 2025 Update

- Every county and city in the state is required to review and, if needed, revise its comprehensive land use plan and development regulations to ensure the plan and regulations comply with the requirements of the Growth Management Act (RCW 36.70A.130(1)).
- Clark County's next update due by <u>RCW 36.70A.130(5)(b)</u>: June 30, 2025

Phase 1: Project initiation (January 2023-Summer 2023)

- Objectives for phase 1:
 - Raise awareness and provide info about the Plan and engagement process
 - Establish preliminary scope of work and PPP
 - Research issues, state law, planning requirements
 - Coordinate with cities, town, tribe, public agencies on population, housing, and employment projections
 - Coordinate with cities, town, and tribe on countywide planning policies

 - Seek out input on proposed new and revised policies
 - Continued coordination with cities, town, tribe, and federal, state, and local public agencies

 - Analysis of preferred alternative through update of Urban and Rural Capacity Estimates, Capital Facilities Plan, Capital Facilities Financial Plan, and Transportation Analyses
 - Preferred Alternative studied in the Final Environmental Impact Statement

Roles and Responsibilities of Decision Makers

County Manager	Prepare and present to the Planning Commission the comprehensive plan update and then presents the Planning Commission's recommendations on these matters to the County Council.
Planning Commission	Appointed by the County Council, the Planning Commission serves as an advisory board on matters related to physical development of land in the unincorporated area. The role of the Planning Commission is primarily legislative because its members review policy proposals and land use changes and provide recommendations to the County Council.
County Council	Elected to four-year terms, members of the Clark County Council hold legislative authority for Clark County. Related to the comprehensive plan update, the council is the ultimate decision maker and responsible for adopting the Comprehensive Plan and related development regulations.
City/Town Councils	Each city and town in Clark County is responsible for creating its own comprehensive plan, policies, and development regulations. The county and the cities' comprehensive plans must be coordinated and consistent with one another. The cities, town, and county work in partnership to collaborate on the update of each comprehensive plan consistent with the requirements and general procedures for designating Urban Growth Areas per WAC 365-196-610.




Public Comments on PPP
