NOTICE ANNOUNCING PUBLIC STATEMENT HEARINGS AND REQUESTING COMMENTS

(Issued September 7, 2022)

The New York State Department of Public Service (the Department) is seeking comments from the public and will hold virtual public statement hearings on the scope of the Management and Operations Audit of the Long Island Power Authority (LIPA) and PSEG Long Island LLC (PSEG LI). The audit is being undertaken by the Department pursuant to the LIPA Reform Act (Public Authorities Law (PAL) \$1020-f(bb) and the Public Service Law \$3-b(3)(d)). It involves the review and evaluation of the overall operations and management of LIPA and PSEG LI with the ultimate goal of improving existing processes, practices, systems, and organizational structures to drive better performance consistent with standards and procedures provided in PAL \$1020-f(u). The audit will include, but not be limited to:

- (i) the PSEG LI's construction and capital program planning in relation to the needs of customers for reliable service;
- (ii) the overall efficiency of LIPA's and PSEG LI's operations;
- (iii) the manner in which LIPA is meeting its debt service obligations;
- (iv) LIPA's Fuel and Purchased Power Cost Adjustment

clause and recovery of costs associated with such clause;

- (v) LIPA's and PSEG LI's annual budgeting
 procedures and process;
- (vi) the application, if any, of the performance metrics designated in the Second Amended and Restated Operations Services Agreement and the accuracy of the data relied upon with respect to such application;
- (vii) LIPA's compliance with debt covenants; and
- (viii) ERM and Corporate Governance.

New scope areas included in this audit are:

- (ix) Climate Leadership & Community Protection Act;
- (x) Cyber Security and System Design & Performance;
 and
- (xi) the implementation of the recommendations from the Department's previous comprehensive management and operations audit of LIPA in Matter No. 16-01248.

Comments received from the public will further inform the issues to be examined in the upcoming audit as defined by these scope areas. The Department has selected NorthStar Consulting Group, Inc., (NorthStar) to perform the Audit on behalf of the Department. NorthStar will utilize these comments in completing the Audit.

Any person wishing to provide a public statement on the record at the hearings must pre-register to do so by 3:00 p.m. on Friday, September 30, 2022. The public statement hearings will continue until anyone wishing to speak has been heard or other reasonable arrangements have been made. A verbatim transcript of

the hearings will be made for inclusion in the record of this proceeding and will be posted on the Department's website.

To register electronically: Participants who would like to provide a statement and will log in to a hearing electronically must register to do so by going to www.webex.com and then clicking "Join" at the top right-hand corner of the screen, entering the appropriate event number listed above, and providing all requested information.

When logging in on the appropriate date and time of the hearing, participants will be asked to "select audio system." It is recommended that participants select the "call me" or "call using computer" option. The "call me" option requires participants to enter their phone number.

To register by phone: Any participant who is not able to log in to a hearing electronically may participate by phone. Call-in participants wishing to provide a statement must register to do so in advance by calling 1-800-342-3330, where they should follow prompts to the appropriate hearing and provide the following information: first and last name, address, and phone number.

On the appropriate date and time of the hearing, all call-in users should dial **518-549-0500** and enter the relevant access code listed above. All participants will be muted upon entry into the hearing.

To listen to the hearings: Any person who would like to listen to the hearings without making a statement may access the hearings without pre-registering. The hearings will be livestreamed on the internet and available for viewing on the Department of Public Service YouTube channel on the date and times listed above.
