Subject: Draft 2023 Wildfire Mitigation Plan Schedule

Dear Wildfire Mitigation Plan Stakeholders:

The Draft 2023 Wildfire Mitigation Plan (WMP) Schedule is presented in Attachment 1 to this letter. The Office of Energy Infrastructure Safety (Energy Safety) is seeking input and feedback from the public and stakeholders on this draft.

Written Determination and Supporting Reasoning for Extension of Three-Month Deadline

Public Utilities Code section 8389.3 requires Energy Safety to "approve or deny each wildfire mitigation plan and update submitted by an electrical corporation within three months of its submission, unless the division makes a written determination, which shall include reasons supporting the determination, that the three-month deadline cannot be met." 1

In view of the changes to the guidelines and process noted below, the schedule provided herein includes extensions to the three-month deadline:

- The upcoming three-year cycle is the second three-year cycle for which electrical corporations are required to submit WMPs. Energy Safety plans to make significant changes to the detailed requirements for the electrical corporations' WMP submittals, as demonstrated by the Draft 2023-2025 WMP Technical Guidelines published September 19, 2022.² These changes include requiring electrical corporations to submit more detailed information that was not required in past submittals. Energy Safety needs additional time to evaluate this new detailed information.
- As discussed in the Draft 2023-2025 WMP Process and Evaluation Guidelines published on September 19. 2022, Energy Safety will evaluate and approve or deny each electrical corporation's WMP for both 2023 and 2024 in its 2023 WMP Decisions.³ Energy Safety

will need additional time to evaluate the detailed targets and projections that the electrical corporations will provide in their WMPs for 2023 and 2024, as opposed to only evaluating these detailed targets and projections for one year.

<u>Draft 2023 Wildfire Mitigation Plan Schedule</u>

As set out in the Draft 2023-2025 WMP Process and Evaluation Guidelines, Energy Safety will conduct a completeness check on the electrical corporations' pre-submitted WMPs (pre-submissions). Following this completeness check, the electrical corporations will submit WMPs for the statutory evaluation process. The proposed 2023 WMP schedule in Attachment 1 covers the completeness check and the evaluation of the electrical corporations' 2023-2025 Base WMPs. The schedule applies to the large Investor-Owned Utilities (IOUs), which are Pacific Gas and Electric Company (PG&E), Southern California Edison Company (SCE) and San Diego Gas & Electric Company (SDG&E), and the Small Multi-Jurisdictional Utilities and independent transmission operators (SMJUs/ITOs), which are PacifiCorp, Liberty Utilities, Bear Valley Electrical Services Inc., Horizon West Transmission, Trans Bay Cable, and LS Power.

Comments on Draft 2023 WMP Schedule

Energy Safety will accept comments on the Draft 2023 WMP Schedule through October 26, 2022, 5:00 p.m. Pacific Time. Comments may be submitted to the 2023-2025 Wildfire Mitigation Plans docket (#2023-2025-WMPs)⁶ and titled "[Commenter Name] Comments on the Draft 2023 WMP Schedule."
