## **Vermont Medicaid Postpartum Eligibility Expansion**

### **Policy Summary:**

The Vermont Medicaid program is expanding the postpartum eligibility period for pregnant Medicaid beneficiaries from 60 days to 12 months from the end of pregnancy. It is also expanding the continuous eligibility requirement for Medicaid beneficiaries who are pregnant or in the postpartum period to disregard certain changes in circumstances, in addition to income changes, during pregnancy and the postpartum period. The continued eligibility of Medicaid for 12 months after the end of a pregnancy will improve the stability of health insurance coverage for people in the postpartum period, which is expected to improve maternal health outcomes.

The American Rescue Plan Act of 2021 made this expansion a temporary option for state Medicaid agencies. The Consolidated Appropriations Act of 2023 made this expansion a permanent option for Medicaid agencies that elect it. Vermont Medicaid will be submitting a state plan amendment (SPA 23-0004) to elect this option. The expansion will be effective April 1, 2023.

Medicaid beneficiaries who are pregnant or in the postpartum period are eligible for full Medicaid benefits. This includes coverage of dental services without the annual cap on dental expenditures and coverage of all medically necessary services on the dental fee schedule as medically necessary. This is more expansive than the Medicaid adult dental benefit. [The Vermont Medicaid Dental Supplement](#) outlines dental coverage during pregnancy and the postpartum period.

Copayments are never required from Medicaid beneficiaries who are pregnant or in the postpartum eligibility period. [Information on copayments](#) can be found on the Department of Vermont Health Access website.
