# **PURPOSE(S) OF ACTION:**

To redraw the district boundaries of the six (6) City of Las Cruces Council Districts.

# **BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

The Las Cruces City Charter requires that there be a "periodic review of the boundaries of the districts" and that each Council district "shall contain as nearly as possible substantially the same population-based upon the most recent federal census." City Council passed Resolution 22-031 creating an ad hoc committee to work with Research & Polling, Inc. to provide public input and evaluate various redistricting proposals. The committee met every two weeks starting in April, reviewing 10 different concept maps and narrowing down to four (4) for council to review.

The four (4) concept maps were presented to the City Council at a Work Session on September 12, 2022. These included Concept Maps B, H-1, J and K. The City Council came to a consensus at the Work Session to move forward with Concept Maps J and K, and to vote on one for approval.

# ORDINANCE 3013; COUNCIL BILL 23-007

AN ORDINANCE TO APPROVE THE REDISTRICTING OF THE SIX (6) CITY OF LAS CRUCES COUNCIL DISTRICTS, REDRAWING DISTRICT LINES, AND REPEALING AND REPLACING LAS CRUCES MUNICIPAL CODE (LCMC) 1997, CHAPTER 8, ARTICLE I, SECTION 8-2. DISTRICT BOUNDARIES ESTABLISHED.

The City Council is informed that:

**WHEREAS**, the Las Cruces City Charter (Charter) Article II, Section 2.01(e) states that "The council shall, be [by] ordinance, set the boundaries of each district"; and

**WHEREAS**, the Charter Article II, Section 2.01(e)(1) states that "Each district shall contain as nearly as possible substantially the same population based upon the most recent federal census"; and

**WHEREAS**, the Las Cruces City Council approved Resolution No. 22-031 on September 7, 2021, establishing the Redistricting Ad Hoc Committee to work with Research & Polling to provide public input and evaluate various redistricting proposals; and

**WHEREAS**, the City of Las Cruces procured the services of Research & Polling, Inc. through a sole source agreement on February 4, 2022; and

**WHEREAS**, the Redistricting Ad Hoc Committee were presented with ten (10) different concept maps and brought forward four (4) for review to City Council at the September 12, 2022, Work Session; and

**WHEREAS**, City Council reviewed the four (4) concept maps and came to a consensus to bring forward concept map J for approval.

**NOW, THEREFORE,** Be it Ordained by the Governing Body of the City of Las Cruces:

**THAT** Las Cruces Municipal Code (LCMC) 1997, Chapter 8, Article I, Section 8-2. District Boundaries Established is hereby repealed and replaced in its entirety as shown in Exhibit "A", attached hereto and made part of this Ordinance.

**THAT** City staff is hereby authorized to do all deeds as necessary in the accomplishment of the herein above.
