

## COMMISSION PACKAGE

### **ACTION REQUESTED:**

Request Type: New Contract

**Purpose of this Commission Package:** Request approval to award Contract No. 17059 for BT6289A17 Allentown Road Water Main Replacement in Prince George's County to Garney Companies, Inc. in the amount of \$30,570,500.00 with a completion time of 980 days.

Basis of Award: This solicitation is being awarded to the lowest, most responsible and responsive bidder.

## **PROJECT OVERVIEW:**

The project Allentown Rd 42" Water Main Replacement (Contract BT6289A17) is located in Temple Hills of Prince George's County, Maryland. It is on Allentown Rd between Old Branch Avenue and Temple Hills Rd. Please see the Project Map at the end of the package for details.

The scope of this Contract consists of the installation of approximately 8,375 feet of new 42-inch water main and 240 feet of new 12-inch water main, replacement of approximately 90 feet of 4-inch water main, 860 feet of 8-inch water main, 35 feet of 10-inch water main, 4,775 feet of 12-inch water main, and 20 feet of 24-inch water main, and relocation of approximately 650 feet of 8-inch water main, 170 feet of 10-inch water main, 3,640 feet of 12-inch water main, and 100 feet of 24-inch water main as well as approximately 2,640 feet of water house connections to serve Allentown Road and various streets in the Temple Hills area of Prince George's County, Maryland.

A community outreach meeting was conducted virtually on June 29, 2021. Less than ten (10) customers attended the meeting.

**OSDI Review:** This solicitation has a 30.00% Minority Business Enterprise and Small Local Business Enterprise (MBE/SLBE) subcontracting requirement that can only be satisfied by WSSC Water-Approved SLBEs (SLBE only or SLBE-SDVs) and the following qualified and certified-MBE firms: African American, Asian American, Native American and Female/Woman-Owned.
