Director

As Director of the Office of Emergency Management & Homeland Security (OEMHS), I am responsible for the coordination of Montgomery County's emergency response activities during county wide emergencies, management and coordination of County homeland security and emergency management grant activities and the vision and management for county-wide planning, training, exercise, mitigation and corrective action programs. Below is a short list of key projects & responsibilities:

- Planning I oversee the entire portfolio of 100+ Emergency Management-related planning activities in Montgomery County. This includes more than 40 departmental Continuity of Operations (COOP) plans, the County's Emergency Operations Plan (EOP) and Hazard Mitigation Plan, the development of the first ever Montgomery County Pre-Disaster Recovery Plan (PDRP), and the recently approved and implemented Emergency Management Program Strategic Plan 2016-2019. These planning efforts routinely require engagement with a diverse array of partners, including non-profits, community advocacy groups, appointed and elected officials and private sector companies. Furthermore, as the most populace county in the National Capital Region (NCR), multi-sectoral planning requires coordination with regional partners in the Commonwealth of Virginia and District of Columbia as well as the counties and municipalities contained therein.
- Operations I have served as the County Disaster Manager and Emergency Operations Center (EOC)
 Manager for multiple emergencies and pre-planned events, including COVID-19, the January 2016
 Blizzard, a significant apartment explosion/fire in Silver Spring, MD in August 2016 and the
 Presidential Inauguration in January 2017. Operated both in the EOC and in the field in support of
 events.
 - COVID-19 and the January 2016 Blizzard was accompanied by a Presidential disaster declaration that provided opportunity for public assistance in cost recovery. I provided oversight for the collective Montgomery County public assistance request process which required close coordination with FEMA Region 3 and resulted in the County, the public school system and our incorporated municipalities recovering more than 10 million dollars in federal disaster relief funding.
 - For COVID-19, I also served as the County Recovery Manager overseeing the transition from response to recovery and planning for future potential expansion of the pandemic and its associated economic impacts.
- Maryland Emergency Response System (MDERS) MDERS is a bi-county partnership between Montgomery County and Prince George's Counties the two Maryland counties represented in the NCR. I was directly involved in the development of this partnership and have served as the Chair of the MDERS Steering Committee since its inception in 2014. This organization represents a partnership between emergency management, law enforcement, fire/rescue services, public health and healthcare in both counties aimed at improving synergies in emergency response. Since forming this organization, I have assisted in securing more than 10 million dollars in UASI funding for joint projects and programs, training, exercises and coordinating planning efforts.
- Training & Exercises I oversee the implementation of a training and exercise program that involves delivery of more than 30 trainings to more than a thousand personnel annually across multiple areas of emergency management and preparedness. As OEMHS Director, I have overseen delivery of more than 12 tabletop, functional or field-based exercises complete with development of after action reports and a robust corrective action tracking and implementation program.
- Grants Administration OEMHS serves as Montgomery County's primary recipient and oversight mechanism for more than \$5 million dollars in emergency management and homeland security-related funding through the NCR Urban Areas Security Initiative (UASI), Emergency Management Performance Grant (EMPG) and State Homeland Security Grant Program (SHSGP). As Director, I have overseen OEMHS's participation in audits conducted by the County and the NCR State Administrative Agency (SAA). All overseen audits have produced zero finding results.



Homeland Security – I serve as the Montgomery County representative to the NCR Homeland
Security Executive Committee (HSEC), the senior committee for regional homeland security policy
and strategy in the Region. This Committee makes final decisions on the approved allocations for the
nearly \$54 million dollars the NCR UASI receives annually. I also serve on the HSEC Policy
subcommittee, which acts as the development center for regional policy initiatives that ultimately are
approved by the full HSEC.

I also serve to provide leadership around the homeland security initiatives in Montgomery County in close concert with other public safety partners. One major area of success has been development and support of our social cohesion & public safety model that has received national recognition as one of the most successful community-oriented efforts to prevent at-risk persons from becoming radicalized to violence. I have served as a key senior advisor to this program for the last 5 years.

Oversee the County's Critical Infrastructure & Key Resource (CIKR) program aimed at identifying and reducing potential homeland security risks for critical sites in Montgomery County.

• Personnel Management – Oversee 18 personnel and contractors including performance management, timekeeping, hiring, discipline and compliance with federal, state and local worker safety codes.

Montgomery County Department of Health and Human Services (DHHS), Silver Spring, MD

I was responsible for oversight of all planning, emergency communications and operational response efforts under the domain of the Public Health Emergency Preparedness & Response program of the Montgomery County Department of Health & Human Services. Key responsibilities and accomplishments included:

- Planning While there are more than 30 associated plans, annexes or procedures that fall under the primary Montgomery County Public Health All Hazards Response Plan, significant modifications utilizing emergency management principles were made to the following plans or annexes under my direction:
 - o Medical Countermeasures Annex
 - Medical Surge Annex
 - o Non-pharmaceutical Intervention Annex
 - o Respiratory Protection Annex
 - Continuity of Operations Annex
 - Volunteer Management Annex

- Operations I served as the County lead for responding to the West African Ebola Outbreak in 2014-2015. Beyond development of the response protocols, I also served as the lead for coordinating County support for housing of potentially exposed, but not ill healthcare workers returning from West Africa, coordinated transport of laboratory samples from ill travelers to the Maryland State Laboratory and worked with hospitals around numerous cases of sick individuals with concerning or unknown travel history.
- Training & Exercises Oversaw conduct of multiple tabletop exercises, two field-based Point of Distribution (POD) drills, and a full-scale mass prophylaxis dispensing exercise.
- Personnel Management Oversaw 8 personnel and contractors including performance management, timekeeping, hiring, discipline and compliance with federal, state and local worker safety codes.
- Partner Collaboration I served as the County representative to the Montgomery County Healthcare Collaborative for Emergency Preparedness (MOCEP) and the Maryland Region V Emergency Preparedness Coalition (EPC). I was selected as the Vice Chair of the EPC in 2014 where I served a two year term providing leadership to the Coalition of 17 acute care hospitals, 5 public health agencies, and emergency medical services agencies. I engaged in routine collaboration with private sector, non-profit and community-based partners on issues related to emergency preparedness and response.

Public Health Program Manager

As the Public Health Program Manager at CHHS, I was responsible for the implementation and oversight of the entire public health and healthcare emergency management portfolio, which included more than 25 distinct projects each with a distinct team of CHHS personnel, clients and project tempos. Highlights of this work include:

- Planning Development over 20 distinct plans for partners that included local health
 departments, hospitals, healthcare coalitions, and academic institutions. These plans included
 both organizational strategic plans and standard operating procedures (SOPs).
- Grants Development Participated in development of 7 distinct grant applications, including multiple successful competitive awards.
- Training & Exercises Developed, facilitated and evaluated more than 20 tabletop, 10 functional and 4 full-scale exercises in a fully HSEEP compliant manner, including development of After Action Reports and Corrective Action Plans.
- Strategic Development Led efforts to expand CHHS's Public Health program, including development of strategic guidance for leadership, meeting with diverse new potential clients and partners, and representing CHHS to key new stakeholder groups.
- Emergency Response Coordination Served as the Emergency Response Coordinator for the Middle Atlantic Regional Center for Excellence (MARCE) a federally funded biodefense program aimed at developing novel treatments and vaccines to bioterror threats. As the Response Coordinator, I maintained the capability for the academic researcher to be available to first responder organizations in the event of a bioterror or emerging infections disease threat.

Health Planner for the Montgomery County Office of Emergency Management & Homeland Security (OEMHS)

In addition to operating as the Public Health Program Manager for CHHS, I was assigned to OEMHS on a contractual basis to operate as the OEMHS Health Planner. Key accomplishments included:

- Planning I led teams or individually was responsible for developing more than 15 distinct
 plans, procedures or operational guides. Past major plans include the state's first Pre-Disaster
 Recovery Plan and a multi-agency Standard Operating Guide (SOG) for Emergency Sheltering.
- Special Projects I was routinely assigned by the OEMHS Director to conduct or lead special
 projects of high significance. For example, I conducted a systematic review of the County 911
 Center operations and provided recommendations that ultimately led to consolidated calltaking/dispatch activities. I also provided support to 2011 Montgomery County Pepco
 Working Group and testified before the Maryland Public Service Commission (PSC) regarding
 the findings and report of the working group. Pepco is the major electrical provider in
 Montgomery County who had encountered numerous major event and "blue sky" related
 outages.
- Operations Participated in more than 15 EOC activations for both disasters and pre-planned events.

2009 - 2010

Public Health Emergency Planner for the Baltimore City Health Department (BCHD) Office of Public Health Preparedness and Response (OPHPR)

While I was contractually detailed to OPHPR, I acted both in a planning and response capacity during the 2009-2010 pandemic influenza response. As a Public Health Emergency Planner for BCHD, I was regularly tasked to lead major emergency management and public health planning efforts. Plans I was specifically assigned to develop include:

- Baltimore City Pandemic Influenza Plan Upon joining the office, I immediately began a rapid
 redevelopment of the citywide pandemic response plan based on recommendations I made prior
 to the pandemic as an intern to the office.
- Baltimore City Medical Surge Plan Plan developed in concert with a multi-agency planning team
 that included private and nonprofit representatives. Produced a strategy for the BCHD situational
 awareness and resource management framework for the City's response to a mass casualty
 incident that produced a medical surge event at the local healthcare facilities.

In addition to serving as a planner, I also performed operational tasking in response to the 2009-2010 H1N1 pandemic. I was assigned to the BCHD H1N1 Incident Command Structure as the Deputy Operations Section Chief working in close collaboration with the Assistant Commissioner assigned as the Operations Section Chief.

Following the H1N1 pandemic, I represented BCHD in the City's Emergency Operations Center (EOC) for the February 2010 snowstorm (Snowmageddon). During the activation, activities included rapid identification of at-risk populations, particularly dialysis patients, whose welfare was endangered by closures and limited travel capabilities. I helped develop the multiagency response to protect those individuals through the coordinated deployment of DOT road clearing assets to allow access to the highest risk individuals. Finally, I conveyed the results and further updates directly to the mayor during briefings.

Emergency Management and Preparedness Intern

I worked as an intern for the Baltimore City Health Department in the Office of Public Health Preparedness & Response (OPHPR). As part of my internship, I conducted a systematic review and analysis of the Baltimore City Pandemic Influenza Plan complete with recommendations for improvement and ongoing considerations for expansion of the plan. This work was completed immediately prior to the spread of the 2009-2010 pandemic H1N1 virus. Many of the recommendations were implemented in real time.

 In addition to this plan review work, I developed guidance for the Health Commissioner on appropriate par levels and deployment criteria for resources and medical countermeasures based upon a review of national best practices and contents of the Strategic National Stockpile.
