#### **COUNCIL DECISION POINTS & COMMITTEE RECOMMENDATION**

• Council sitting as Board of Health to receive updates.

#### DESCRIPTION/ISSUE

The Council will receive an update on the public health data and response to COVID-19. The Council's discussion today will focus on the impacts of current COVID 19 conditions on MCPS operations and the collaboration between MCPS and DHHS public health leadership to support COVID-19 planning and response in the schools. DHHS will also provide a brief overview of public health data.

#### **Background Information**

#### Montgomery County Public Schools (MCPS)

On January 9, 2022, MCPS issued a community message with updated guidance for quarantine and isolation protocols. The most recent comprehensive community message on this issue is at the link below:

MCPS is experiencing operational impacts due to staffing shortages in critical areas as well, including substitute teachers and school bus operators. The Board of Education received an update on MCPS operational impact of COVID-19 on January 13, 2022. The information that was presented to the Board of Education is attached to this report.

#### State and County Data on January 13, 2022 (Maryland.gov website)

On January 13, 2022, the Maryland.gov website reported the State's positivity rate was 25.45%.

On January 6, 2022, the CDC COVID<sup>1</sup> Tracker by county, showed that Montgomery County was in **HIGH** Community Transmission with a case rate of 1,892 cases per 100,000 population for the last 7 days and a positivity rate of 25.02%.

The January 13, 2022, CDC COVID Tracker reports:

89.7% of the County population aged 5 years old and older is fully vaccinated.

84.2% of the TOTAL County population is fully vaccinated.

44.3% of the fully vaccinated population has a booster.

#### Montgomery County Case Metrics (from Montgomery County website)

Montgomery County continues to monitor metrics regarding the spread and prevalence of COVID-19 in the community. The primary indicators follow the CDC Tracker which classifies metrics by Low, Moderate, Substantial, and High. The secondary metrics are classified as the county as Very High, High, Moderate, Low, or Very Low risk of transmission/utilization. #### **Primary Indicators**

Number of cases per 100,000 residents in the past 7 days. As of January 13, 2022, the County website reports 1892.0 cases per 100,000; which was a **HIGH** level of transmission.

Test positivity rate – 7-day average percentage of tests administered resulting in a positive case. As of January 13, 2022, the positivity rate is reported to be 25.1%; this was a **HIGH** level of transmission.

#### Secondary Indicators

Percent change in new cases per 100,000 population during the last seven days compared to the previous seven days. As of January 13, 2022, the percent change in the new case rate was 13.6%; a **HIGH** risk of transmission.

Percent of hospital inpatient beds in the community that are occupied. As of January 13, 2022, 72.7% beds were occupied which is a **LOW** rate of utilization. (It has been noted in previous updates that it is not just the number of beds that a hospital has available but also availability of staff to allow the beds to be occupied by patients.)

Percent of Intensive Care Unit (ICU) beds in use. As of January 13, 2022, 85.1% of ICU beds were in use which is a **MODERATE** rate of utilization.

Percent of inpatient beds in the community occupied by patients with COVID-19. As of January 13, 2022, 36.1% of beds were occupied with COVID-19 patients which is a **HIGH** rate of utilization.

#### Board of Health Order – Masks – January 4, 2022

On January 4, the Board of Health adopted an amended Board of Health regulations regarding the wearing of masks that became effective at 12 a.m. on January 5, 2022. The new Board of Health regulation continues indoor mask requirements at any location accessible to the public in Montgomery County until at least Jan. 31, 2022 at 11:59 p.m. In addition, the Council will meet as the Board of Health every two weeks to evaluate the public health data associated with community transmission of COVID-19 to determine if the indoor mask mandate should continue.



# **Elementary Quarantine Instruction**

# **Framing the Context**

### Background:

- In August 2021, we launched a support plan for elementary students in isolation or quarantine.
- Current Features:
  - Live instruction in literacy and math
  - Recommendations for independent activities
  - Opportunities for students to check in live with school staff
- All schools were provided with the same design guidance, but were permitted to either serve students as a local school or participate with shared staff and students from all other elementary schools in a regional model. (70 local model, 65 regional model)
- As the pandemic and positive case rates have increased, the number of students in isolation and quarantine, combined with demands for school staff to provide coverage for in person learning, have exceeded the model capacity and a revision is required. (7)

## **Revised Model for All Elementary Schools**

Some features of the systemwide model includes the following:

- ✓ Utilizes existing MCPS Canvas Sites (no Zoom)
- Provides On Demand Video Screencasts (Can access at the time each day that works for each family)
- Continues to prioritize Literacy and Math Only
- Continues to use an existing quarantine pacing guide.
- Opportunities for students to continue to interact with the learning objectives at their grade level during their short term absence due to COVID safety protocols.
- There will be no homework, no assignments, no grading, and no direct interaction with the instructors.
- Will apply to all elementary schools and launch on Tuesday, January 18, 2022.

# **Secondary Quarantine Instruction**

## **Secondary Quarantine Instruction**

Based on multiple stakeholder collaborative engagement, secondary quarantine includes:

- The option for teachers to zoom students into the class for live streaming **or** meet with them during a non-instructional period of the day.
- Secondary teachers will choose, based on the content and circumstances, which option makes the most sense for their students in quarantine.

## **Secondary Quarantine Instruction**

## What It Is

- Teachers can decide individually which method matches the day's lesson and their preference for how best to support quarantine students. Teachers need to communicate the method of support to their quarantine students.
- A support to students using Canvas assignments/information to keep up with class.
- A livestream of the class activities that day.

## What It Is Not

- Required of all teachers for every class, every day.
- Simultaneous instruction where the teacher has to plan interactive strategies with the students who are live streaming.
- The only method of supporting quarantine students (They still will have counselor contact and use of the Canvas page work.)

## **Access and Supports for Students and Families**

### **Student Supports, Updates and Commitments**

- MCPS will support students whose parents have communicated their desire to keep their students home due to current COVID-related safety concerns. This will extend through January 31, 2022, with the possibility of an extension.
- Schools will leverage their **well-being teams** to determine if students/families need this **temporary support on a case-by-case basis**.
- OTLS will **engage with schools** in alignment with existing MCPS and State attendance policies and regulations to determine how a student's attendance will be documented.
- In collaboration with our employee association partners and our school leadership teams, we will develop appropriate opportunities for students to access instruction.

# **Transportation Update**

### **Driver Shortages and Context**

Like others in transportation and neighboring districts, MCPS Department of Transportation (DOT) has experienced many vacancies (140 at the height)

- Vacancies reduced by 40% by November; but increased to more than 100 by winter break due to retirements and other transitions
- Recently, we have experienced unprecedented absences: personal, sick, and COVID leave
  - We reached a point the week of January 3 when we were unable to service 8% of our routes

# **Transportation Update**

## **Routing Priorities**

- Coverage for special education students
- Routes transporting students to the four holding schools (Burnt Mills, Stonegate, South Lake, and Woodlin elementary schools)
  - Prioritized due to the distances the holding facilities are from the neighborhoods in the school catchment area
- Other special programs such as vocational programs at the Thomas Edison High School of Technology
  - Prioritized due to hour requirements for student learning

# **Transportation Update**

## **Our Plan Going Forward**

- Communicate specific routes and affected schools through updates on the DOT page and the MCPS homepage
  - The initial list for each day will be posted by 7:00 pm on evening prior;
  - Additions may be included each morning.
- Schools will also share directly with families
- Continue to use available staff to drive and cover routes
- External outreach National Guard, County, Fire and Rescue
- Internal outreach- retirees, MCPS staff, and hiring 'pipeline

# Individual School Transitions to Virtual Instruction

MCPS leadership in consultation with the Montgomery County Department of Health and Human Services (DHHS) and individual school leaders will examine schools on a case-by-case basis and determine whether a school needs to transition to virtual learning for a designated period of time for health and/or operational reasons.

### **Review of School Operations**

Multiple factors will be considered to inform a decision for an individual school to transition to virtual learning.

- Positive case rates for students and staff spanning a 10-day period
- Student absences
- Staff absences
- Unserved bus routes
- Unfilled substitute requests
- School perspective on ability to safely and effectively operate

(Note: the numbers associated with these data points will be examined for trends over time and higher averages. No one data point is considered as a threshold for decision making).

The trends from these factors will be analyzed on a case-by-case basis.

Considerations are made for how daily operations impact:

- School
- School programs
- Grade levels

### **Collaborative Discussion of School Operations**

- Montgomery County Department of Health and Human Services
- Principal
- Elected Supporting Services Representative
- MCEA Building Representative
- Parent Community Leadership
- Central Office Staff

Recommendations to move to virtual instruction will be forwarded for approval to the interim superintendent's cabinet.

Final decisions will also be informed by discussions about:

- health and wellness impacts in consultation with the Montgomery County Department of Health and Human Services
- school leadership assessment of operational readiness, and
- any impacts to school specific programs.

### Notification to Staff, Students, and Community

- Communication and Outreach
  - Email
  - Connect Ed
  - Website notification
  - Other social media
- After a school is identified, the process will take no more than two business days.
- The length of the transition to virtual learning will be 10 calendar days.
