## DESCRIPTION/ISSUE

There are significant gender disparities that persist in local sports programs with girls and women accessing fewer participation opportunities than boys and men. Gender disparities in sports participation begin when children are young and widen as they reach middle school, and more dramatically during high school. Because of these disparities, girls are not able to benefit from the improved health, social and life outcomes associated with sports participation. In addition, access to sports programming has also been negatively affected by the COVID-19 pandemic.

## SUMMARY OF KEY DISCUSSION POINTS

- This appropriation will expand affordable, accessible recreational sports programming tailored to the interests of girls at all levels, to increase their participation in sports and reduce the drop-off in participation as they age into middle school and high school.
- This appropriation will provide $\$ 100,000$ to the Department of Recreation to engage elementary and middle school girls in volleyball, softball, lacrosse introductory activities and instructional skills classes and clinics, with the goal of establishing County-wide recreational leagues for these sports in FY23. Funding will also support expansion of the Soccer 4 Change girls' program.

## Background

1. Section 308 of the County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
2. According to the Office of Legislative Oversight Report "Gender Equity in Local Sports Programs," significant gender disparities persist in sports nationally, "with girls and women accessing fewer participation opportunities than boys and men." Data from the Aspen Institute's Project Play, cited by the report, show that gender disparities in sports participation begin when children are young and widen as they reach middle school and more dramatically during high school, with girls leaving sports at rates that were two to three times higher than that for boys.
3. The impact of the COVID-19 pandemic has resulted in reduced access to youth sports programming. According a September 2021 survey conducted by the Aspen Institute in collaboration with Utah State University, families face reduced supply of youth sports programs, with $44 \%$ of respondents reporting that community-based programs they used have closed, merged with other programs or returned with limited capacity; half of respondents report that fear of their child getting sick is a barrier to resuming sports participation; and nearly $30 \%$ of parents reported that their child has lost interest in playing organized sports.
4. These national trends described in paragraphs two and three are consistent with sports participation in Montgomery County. For example, between FY17 and FY20, girls were only one third of all youth participants in Department of Recreation basketball leagues. Many private and nonprofit sports providers in Montgomery County also serve more males than females, as reported through a survey of 26 providers conducted by OLO that showed an average of $36 \%$ female participants.
5. The decrease in overall participation in youth participation in County recreation programs and widening of gender disparity rates reflected in post-pandemic registration data evidence the urgent need to provide sports opportunities that meet the needs of girls in the County. There was a decrease in total registrations for youth basketball from FY19 to FY20 of 545, or $7.4 \%$. Moreover, the gap between 14-18 year-old girls and boys widened with registration for girls amounting to just $13.8 \%$ of total registrations, in contrast to $19.6 \%$ for the previous year.
6. The participation by girls in youth sports also varies significantly by geographic location in the County. District 3 (Poolesville), District 7 (Bethesda, Glen Echo and Somerset), and District 10 (Potomac) had higher overall registration rates than other districts -89 to 135 registrations per 1,000 population. In contract, District 9 (Gaithersburg, Montgomery Village, and South Germantown) and District 5 (Burtonsville and White Oak) had six to eight registrations per 1,000 population.
7. This appropriation will expand affordable, accessible recreational sports programming tailored to the interests of girls at all levels, to increase their participation in sports, reduce the drop-off in participation as they age into middle school and high school, and convey the improved physical, mental health, social and emotional development, and educational and workforce outcomes associated with sports participation.
8. This appropriation will provide funding to the Department of Recreation to engage elementary and middle school girls in volleyball, softball, and lacrosse with introductory activities and instructional skills classes, and clinics, with the goal of establishing County-wide recreational leagues for these sports in FY23. Funding will also provide for the expansion of the Soccer 4 Change girls program as well as support field and gym permitting fees, equipment, outreach, and contracted program delivery.
9. Notice of public hearing was given and a public hearing was held.
10. The County Council declares this request is in the public interest to be acted upon without delay as provided for under special appropriation requirements described in Article 3, Section 308 of the Montgomery County Charter.

Re: Special Appropriation for New Sports Programs for Girls

Last month we received OLO's report, Gender Equity in Local Sports Programs, which described the significant participation gap in youth sports between boys and girls and the widening of the gap as kids age. The report found that most providers of youth sports - including the Department of Recreation, private and non-profit providers, and MCPS athletics programs serve more males than females and few have targeted efforts to recruit more females. Thousands of kids, girls in particular, continue to miss out on opportunities to participate in sports.

As a starting point to fill this gap, we are seeking your support for a $\$ 100,000$ Special Appropriation for the Department of Recreation to provide engagement programs and activities in Spring and early Summer 2022. This appropriation will provide funding to engage elementary and middle school girls in four of the most popular sports for high school girls: volleyball (the most popular sport among girls in 21 states), softball, and lacrosse introductory activities and instructional skills classes, and clinics, with the goal of establishing County-wide recreational leagues for these sports in FY23. This appropriation would also allow for the expansion of Recreation's successful Soccer 4 Change girls program.

This appropriation will expand affordable, accessible recreational sports programming tailored to the interests of girls at all levels, to increase their participation in sports, reduce the drop-off in participation as they age into middle school and high school, and convey the improved physical, mental health, social and emotional development, and educational and workforce outcomes associated with sports participation.

During the upcoming FY23 Operating Budget discussion, we will also be requesting additional funding for Recreation to enable them to expand these engagement activities to build out leagues in three of the previously mentioned sports: volleyball, softball, and lacrosse.
