



Nebraska Corn Board Market Development and Innovation & Stewardship Internship Lincoln, Nebraska

Timeframe

August 2023 – May 2024 with opportunity for May - August fulltime hours based upon intern experience and availability

Duties & Responsibilities

- Assist and coordinate stewardship & innovation projects, including:
 - Data entry for maintaining market intelligence spreadsheets, including crop progress, supply and demand metrics for corn, ethanol, beef, etc.
 - Develop visuals within excel to inform board members on market intelligence updates
 - Attend field day or partnership events and lectures and develop summaries/take pictures for social media postings
 - Seek out relevant topics for quarterly newsletter and create content from research, interviews, etc.
 - Assist with the research funding program process, including review of submitted proposals and discussion of research priorities among board sub-committee members
 - Assist with program and event planning duties
- Assist with market development programs, including:
 - Ethanol or biofuels promotion
 - Activities for domestic or international marketing missions
 - Attend market development seminars online or in-person and create summary of discussion
 - Analyze articles on trade that will impact domestic corn markets
 - Research studies on biofuel uses such as sustainable aviation fuel (etc.)
- Assist with outreach programs and activities, including:
 - International trade teams, new corn product market development, & assisting with promotional events
- Collect and report corn and corn product utilization and transportation data
- Assist with various duties in office, such as mailings, copying, filing, maintaining the corn van, etc.

Qualifications

- Any student enrolled in a four-year university located in Lincoln, Nebraska with the following qualifications:
 - Proven communication abilities in written, verbal, and online forms of communications
 - Excellent computer skills
 - Working knowledge of Microsoft Office products, specifically Excel
 - Agriculture background beneficial but not required

Hours Per Week

- May – August: 40 hours/week (with flexibility for summer course work)
 - Opportunity for summer internship hours based upon intern experience and availability
- August – May: 15 – 20 hours/week (Will work with student's academic schedule)
- Office hours are 8:00 a.m. and 5:00 p.m. (some work will be on nights and weekends)

Other Opportunities

- Evening and weekend events required occasionally
- Vehicle provided when driving required
- Opportunity for out of state travel (to Washington, D.C. for NCGA Corn Congress or Commodity Classic)
