## APPROVED TEXT OF PROPOSED REGULATION ACTION Amend Commission Regulation 1005 Minimum Standards for Training – Course Name Correction

## § 1005. Minimum Standards for Training.

## Amend

§ 1005. Minimum Standards for Training. (Refer to Commission Regulation 1007 and Commission Procedure H for Reserve Peace Officer Training Standards). 11 CCR § 1005 (a)-(d)(2)\*\*\*[Remain Unchanged]\*\*\*

- (d) Continuing Professional Training (CPT) (Required)
  - (3) Qualifying and Non-Qualifying Training

Subsection 1005(d) CPT requirement is met by satisfactory completion of one or more POST-certified courses totaling a minimum of 24 hours, as referenced below.

(A) While recommended topics for CPT are listed in Commission Procedure D-2, POST-certified training courses may be used for CPT credit, with the exception of the following POST-certified courses that do not qualify for CPT:

Regular Basic Course - Standard Format Regular Basic Course - Modular Format (all components) Field Training Program

**Investigation and Trial Preparation Course** 

District Attorney Investigator Transition Course

Specialized Investigators' Basic Course PC 832, Arrest and Firearms Course Coroners' Death Investigation Course

Campus Law Enforcement Course

**Aviation Security Course** 

Public Safety Dispatcher's Basic Course

**POST Requalification Course** 

POST Workshops (those designed to provide input or advice to POST)

Field Management Training Team Building Workshops
