Thompson Road-Kenny Terrace realignment/connection project

Land Use and Transportation (LUT) has been planning to connect Thompson Road westbound along the Kenny Terrace alignment (west of Saltzman) since 2002, when the original subdivision was planned. Funding is now available, and evolving plans have been presented over several meetings last year and this year.

We will present a brief history of the road at this location, show some of the slides that were shared during the August 31 Community Meeting, and allow time for neighbors to express their concerns, including sidewalk connections, tree replacement, and design questions.
