AB 617 Community Air Protection Program Fifth Annual Community Recommendations

In July 2017, Assembly Bill (AB) 617 was signed into law. The California Air Resources Board (CARB) established the *Office of Community Air Protection Program (Program)* to implement AB 617, which requires community-focused action to reduce air pollution and improve public health in communities that experience disproportionate burdens from exposure to air pollutants. AB 617 requires the CARB Board to consider the selection of additional communities annually, as appropriate.

The Program consists of multiple elements that work together to address specific community air pollution concerns. Community partnerships and leadership are central to this process. Air districts, in partnership with communities, develop Community Emission Reduction Programs (CERPs) and/or Community Air Monitoring Plans (CAMPs).

Selected Communities and Community Steering Committees




Every year, the CARB Board considers selecting communities to develop CERPs, CAMPs, or both. Since the beginning of the Program in 2018, CARB has selected a total of 17 communities. Community Steering Committees are actively working to develop, implement, and monitor these local efforts. While all communities have unique characteristics, there are many common air quality challenges throughout the State.

Annual Community Consideration Process

Community self-nominations for communities can be submitted at any time and are submitted through *communityair@arb.ca.gov*. CARB staff encourages community members to work with their air district on recommendations. Air districts are requested to submit recommendations in the Fall for CARB staff to assess communities for recommendation to the CARB Board.

Fifth Annual Community Recommendations



CARB annually considers highcommunities. Staff priority recommends communities based on several factors, as shown in the figure to the left and outlined Program Blueprint (October 2018). 1 CARB's staff recommendations are based on the combined support of the air district and the community's nominations. For the fifth annual community recommendations. CARB staff is recommending two

new communities. Listed below are the proposed new communities, proposed action, and preliminary community details. The CARB Board will consider staff recommendations on February 23, 2023, at 4:00 p.m. See the *February agenda* posted 10 days before the Board meeting. Fifth Annual Community Air Protection Program Staff Report was released on January 23, 2023. Comments can be submitted through Monday February 13, 2023.


