EMERGENCY CLOSURE of BLM lands impacted by Monument Fire in Trinity County

ACTION: Notice of Emergency Closure of Public Lands

SUMMARY: Notice is hereby given that public lands managed by the Bureau of Land Management (BLM) associated with emergency fire suppression actions for the Monument Fire in Trinity County are closed to public access to reduce risk to public and firefighter safety. This closure includes BLM in the Helena area, Canyon Creek area, Junction City area, and Hayfork area. Previously closed BLM lands near Weaverville and Douglas City, CA have been re-opened. See attached map for exact boundaries. Exempted from this closure are BLM recreation sites on the Trinity River near Junction City, CA. Sites include Junction City Campground, Baghdad Boat Launch, Sky Ranch Boat Launch, and Junction City Boat Launch. Grapevine day-use area remains closed. Other exceptions to this order include personnel and vehicles involved with fire suppression, and state, local and federal officials involved with enforcement.

EFFECTIVE DATE: This closure is in effect with the posting of this notice and remains in effect until the authorized officer determines that the fire no longer poses a risk to public safety and the facility is no longer needed to support fire suppression efforts. This closure is effective pursuant to 43 CFR Subpart 83464.1 (a).
