
Suicide Rates in California, 1981-2020

Number of Suicide Deaths in California, 2011-2020



Monthly Observed and Projected Suicide Deaths in California, 2015 - 2020








Suicide Rates (Risk) by Gender, 2011-2020








Suicide Rates (Risk) by Age Group, 2011-2020








Suicide Rates by Race/Ethnicity in California, 2011-2020






Mechanism of Suicide in California, 2019 & 2020







Suicide by Firearm, Gender, California, 2019 & 2020






Suicide by Firearm, Age Group, California, 2019 & 2020






Suicide by Firearm, Race/Ethnicity, California, 2019 & 2020


Suicide Rates (Risk) among Youth (Ages 10-24) by Race/Ethnicity in California, 2011-2020


Summary of Suicide Findings/Trends

- Number of suicides overall in California has decreased in 2020.
- Suicide rates of certain subgroups have increased in 2020:
 - 10-18 year olds
 - People who are Asian/Pacific Islander
- Suicide rates among certain subgroups of youth (ages 10-24) have increased in 2020:
 - Youth who are Black
 - Youth who are Hispanic
 - Female youth
- The use of firearms as a mechanism for suicide has increased in 2020, especially among individuals who are Black.




Self-harm Emergency Department (ED) visits

- Non-fatal
- Treat and release (exclude same facility hospital admits)
- CA residents in CA facilities
- Any mention of a self-harm injury*
- Excludes newborns and age >119
- Data available through June 2021






Monthly Self-harm ED Visits in California, 2017 – June 2021





Monthly Self-harm ED Visit Rates in California, 2019 -2021








Average Monthly Self-Harm ED Visit Rate (Risk) by Sex, 2019-2021



Average Monthly Self-Harm ED Visit Rate (Risk) by Age, 2019-2021








Average Monthly Self-Harm ED Visits (Burden) by Race/Ethnicity, 2021




Average Monthly Self-Harm ED Visit Rate (Risk) by Race/Ethnicity, 2019-2021





Self-harm ED visit summary

- Overall:
 - California ED visits declined in March and April 2020 then returned to 2019 levels by July 2020
 - From July 2020 to June 2021, California ED visits remained roughly at 2019 levels
- In the first half of 2021, ED visits were greater than 2019 levels among:
 - Females
 - Youth aged 10 18 years
 - Californians who are Hispanic, Asian/PI, or multiracial
 - Cut injury visits
