COVID-19 Testing and Proof of Vaccination Policy

POLICY

The COVID-19 pandemic presents an unprecedented challenge. The virus is highly contagious, including among asymptomatic people, and potentially deadly. According to the Centers for Disease Control and Prevention (“CDC”) and the Minnesota Department of Health (“MDH”), the best way to prevent infection and from spreading the disease is by being vaccinated. COVID-19 vaccines have proven themselves to be safe and effective. Staff who access the workplace or provide public service outside of their homes on behalf of the MPRB without vaccination pose a particular risk of COVID-19 exposure to themselves, their colleagues, and to members of the public. Additionally, ongoing community transmission of more transmissible variants of COVID-19, especially among unvaccinated individuals, presents a continuous risk of infection. An alternative to vaccination is regular testing for COVID-19 infection, in conjunction with the use of face coverings and social distancing, as determined appropriate by federal, state, and local public health entities.

1. It is the Policy of the Minneapolis Park and Recreation Board to require regular testing for COVID-19 infection for all Covered Persons. This Policy further encourages Covered Persons to become fully vaccinated against COVID-19 by permitting Covered Persons to opt out of mandatory testing by providing proof of full vaccination.
2. The Superintendent or their designee is directed to develop and maintain procedures to implement and support this Policy, which may include prioritizing implementation of this Policy to certain areas and/or a phased implementation in those areas presenting the greatest risk of exposure.
3. This Policy applies to Covered Persons, as defined here. A Covered Person, for purposes of the Policy, is defined as a person who performs services for the Minneapolis Park and Recreation Board with or without compensation, including:
 1. Regular full-time, part-time, seasonal and intermittent employees in the classified service;
 2. Seasonal employees;
 3. All employees in the unclassified service including appointed employees;
 4. Politically appointed employees;
 5. Elected Officials;
 6. Temporary employees;
 7. Interns including Urban Scholars and Step Up Interns; and
 8. All contractors and volunteers deemed by the Superintendent or their designee to have close contact with the public or members of MPRB staff.
4. The Policy is designed to protect, to the extent reasonably possible, Covered Persons and the public from the direct threat resulting from the spread of COVID-19 in the workplace and other persons visiting the workplace and/or working with Minneapolis Park and Recreation Board (MPRB) staff.

DEFINITIONS (OPTIONAL SECTION)

Covered Person - a person who performs services for the Minneapolis Park and Recreation Board with or without compensation, including:

1. Regular full-time, part-time, seasonal and intermittent employees in the classified service;
2. Seasonal employees;
3. All employees in the unclassified service including appointed employees;
4. Politically appointed employees;
5. Elected Officials;
6. Temporary employees;
7. Interns including Urban Scholars and Step Up Interns; and
8. All contractors and volunteers deemed by the Superintendent or their designee to have close contact with the public or members of MPRB staff.

Fully Vaccinated - Meeting the current CDC guidelines for full vaccination against COVID-19.

For example, at the time of this Policy's adoption, the CDC considers people to be fully vaccinated against COVID-19:

- 2 weeks after their second dose in a 2-dose COVID-19 vaccination series approved by the U.S. Food and Drug Administration ("FDA") or the World Health Organization ("WHO"); or
- 2 weeks after a single-dose COVID-19 vaccine approved by the FDA or the WHO.

This Policy recognizes that the CDC may change or revise its definition, and the definition of "Fully Vaccinated" under this Policy is intended to be consistent with the CDC's then-applicable definition.

Staff who do not meet these requirements are NOT fully vaccinated.

COVID-19 Test - A diagnostic test to determine if someone has an active COVID-19 infection. As methods become available, recommended tests may include a polymerase chain reaction (PCR) test or an antigen test. A test will be administered by contracted medical personnel or potentially self-administered based on guidance from local public health experts and/or occupational medicine physicians.

Workplace - Any location outside of a staff member's home where MPRB work is performed, or any location visited by the staff member for more than 10 minutes while on work time.

ROLES AND RESPONSIBILITIES

All employees of the Minneapolis Park and Recreation Board play important roles in ensuring compliance with this Policy. MPRB employees must comply with the responsibilities as outlined below and in accordance with applicable procedures.

Covered Persons

1. Comply with all aspects of this Policy.
2. Maintain confidentiality of data that is not public and provide information only to those with a business need to know.

Superintendent or their Designee

1. Establish, manage, and modify procedures necessary to carry out and comply with this Policy in the workforce. Such procedures should include setting standards and expectations for mandatory testing of Covered Persons and for the vaccination opt-out protocol.
2. Ensure procedures are in alignment with local, state and federal health standards and regulations.
3. Monitor local, state, and federal health standards and regulations and public health trends related to COVID-19.
4. Maintain confidentiality of data that is not public and provide information only to those with a business need to know.

Division Heads

1. Communicate this Policy to Covered Persons, as well as communicate and reinforce expectations to leaders, managers and employees
2. Require covered staff to comply with this Policy, including sending staff home and/or taking other action for non-compliance when appropriate.
3. Maintain confidentiality of data that is not public and provide information only to those with a business need to know.

Managers and Supervisors

1. Inform their employees for whom they are responsible of the expectations outlined in this Policy;
2. Achieve and maintain compliance with this Policy; and
3. Take timely and appropriate action when a complaint is made alleging violation of this Policy.
4. Maintain confidentiality of data that is not public and provide information only to those with a business need to know.

Department Directors

1. Communicate this policy to covered persons and reinforce expectations to managers and employees.
2. Require covered staff to comply with this policy, including sending staff home and/or taking other action for non-compliance when appropriate.
3. Comply with directives from Division Heads in furtherance of this Policy.
4. Maintain confidentiality of data that is not public and provide information only to those with a business need to know.

Human Resources Staff

1. Understand and perform responsibilities as it pertains to this Policy.
