**SUBJECT:** Amendment to the Master Plan for Historic Preservation: Potomac Overlook

PURPOSE: Review the resolution to amend the Master Plan for Historic Preservation

The Planning Board Draft Amendment to the Master Plan for Historic Preservation for the Potomac Overlook Historic District contains the text and supporting documentation for the amendment to the Master Plan for Historic Preservation in Montgomery County, Maryland (1979), as amended; Bethesda-Chevy Chase Master Plan (1990), as amended; and The General Plan (on Wedges and Corridors) for the Physical Development of the Maryland-Washington Regional District in Montgomery and Prince George's Counties (1964), as amended.

The Amendment covers nineteen houses located approximately two-and-a-half miles to the southwest of downtown Bethesda and overlooking the Potomac River. In July 2019, the majority of Potomac Overlook residents signed a petition and requested evaluation of the subject properties for potential listing and protection under Section §24A of the Montgomery County Code.

This proposed historic district meets four Designation Criteria of the Historic Preservation Ordinance as listed in Section §24A-3 of the County Code. The district is a significant example of a residential development resulting from the collaboration of merchant builder Edmund J. Bennett and the architecture firm of Keyes, Lethbridge, and Condon (KLC). Potomac Overlook was the first major subdivision built by this collaborative partnership. Bennett and KLC espoused the aesthetic design, functional advantages, and untapped commercial potential for modern architecture in tract housing. In addition, the subdivision reflected the development team's recognition of the importance of site development and land planning in creating communities respectful of the natural surroundings, topography, and tree canopy. The contemporary-styled dwellings are recognized as outstanding examples of situated modernism. In addition, the contributions of several of the first homeowners in

Potomac Overlook augment the historic significance of the district. This amendment to the Master Plan for Historic Preservation recognizes the achievements of six owners who influenced local, state, and national affairs.

On June 9, 2021, the Historic Preservation Commission (HPC) recommended that the Planning Board list the subject property in the Locational Atlas and Index of Historic Sites. On November 18, 2021, the Planning Board held a public hearing, worksession, and action on the subject plan. The Board listed the property in the Locational Atlas & Index of Historic Sites and recommended to the Council amending the Master Plan for Historic Preservation to list the subject properties as a Master Plan Historic District. Resources designated in the Master Plan for Historic Preservation are subject to protections under the Historic Preservation Ordinance and may qualify for certain benefits including historic preservation tax credits.
