Introduction

SUBJECT

Special appropriation to the FY21 Operating Budget, Montgomery County Economic Development Corporation Non-Departmental Account, Restaurant Relief Grant Program; and amendment to FY21 Operating Budget Resolution 19-472, Section G, Designation of Entities for Non-Competitive Contract Award Status: Montgomery County Economic Development Corporation

DESCRIPTION/ISSUE

The Executive requests approval of the subject resolution to implement a second round of funding for the Restaurant Relief Grant Program. This program is fully funded through a State grant. The Montgomery County Economic Development Corporation (MCEDC) will implement the program for the County like it did for the first round.

SUMMARY OF KEY DISCUSSION POINTS

- The public hearing and action for the subject resolution are tentatively scheduled for Tuesday, January 26, 2021 at 1:30 PM.
- The source of funding is a State grant and the grant agreement between the County and State govern the use of the funds.
- The resolution conditions the funding for entities that: 1) directly provide food service (restaurants, food trucks, caterers, wineries, and breweries); 2) have principal places of business in the County; 3) are in good standing with Maryland; 4) require financial assistance permitted by the State grant; and 5) have not and will not use funding from the County through other COVID-19 grant programs to fund the same expenses for the State grant.
- MCEDC will administer the grant for the County. The resolution also amends Section G of the FY21 Operating Budget resolution, so the County can amend its contract with MCEDC to implement this funding.

Montgomery County Government, Montgomery County Economic Development
Corporation Non-Departmental Account, Restaurant Relief Grant Program,
\$4,938,298

I am recommending a special appropriation to the FY21 Operating Budget of the Montgomery County Economic Development Corporation (MCEDC) Non-Departmental Account in the amount of \$4,938,298. This appropriation will provide additional funding of the County's Restaurant Relief Grant Program.

The Governor has announced a \$30 million additional investment to their original \$50 million Restaurant Relief Fund. The Maryland Department of Commerce has conveyed that Montgomery County's allotment for this program totals \$4,938,298, funds whose use and requirements will be governed by a grant agreement between the Department of Commerce and the County. According to the State, the purpose of this grant program is to enable Montgomery County to provide grants to restaurants in order to promote and encourage stabilization within the restaurant and hospitality industry.

MCEDC, collaborating with the County's Business Advancement Team, has agreed to administer the County's Restaurant Relief Grant Program, including promotional activities, application reviews, grant disbursements, and required reporting activities all in accordance with the Maryland Department of Commerce's grant agreement governing the use of these funds.

We are proposing that local entities eligible to receive a financial award up to \$10,000 include: restaurants, food trucks, caterers, wineries, and breweries that directly provide food service, individual locally owned franchised restaurants, and restaurants in hotels and in arts/entertainment/recreational facilities. An entity will be eligible to receive assistance from the Restaurant Relief Grant Program if it: 1) has its principal place of business in Montgomery County; 2) is in good standing with the State of Maryland; 3) requires financial assistance to pay for the expenditures permitted by the State through its appropriation to Montgomery County; and 4) has not used, and will not use, funds received from this grant program for the same purpose as funds received through other Montgomery County grant programs. A business that has permanently closed will not be eligible for the Restaurant Relief Grant Program.

MCEDC and the County will market this program in conjunction with the existing 3R and Reopen Montgomery grant programs and will work with business organizations throughout the community to publicize the availability of these collective funding sources.

I recommend that the County Council approve this special appropriation in the amount of \$4,938,298 and specify the source of funds as State Funds.

I appreciate your prompt consideration of this action.

SUBJECT: Amendment to the Fiscal Year 2021 Operating Budget
Resolution 19-472, Section G, Fiscal Year 2021 Designation of Entities for
Non-Competitive Contract Award Status

The Office of the County Executive (CEX) is requesting to amend the Fiscal Year (FY) 2021 Operating Budget Resolution 19-472, Section G, FY21 Designation of Entities for Non-Competitive Contract Award Status to add a new contract with the Montgomery County Economic Development Corporation in the amount of \$4,938,298 to administer a Restaurant Relief Grant Program.

The Governor has announced a \$30 million additional investment to their original \$50 million Restaurant Relief Fund. Montgomery County has been allocated \$4,938,298 from the State for direct relief for restaurants in the County. The Montgomery County Economic Development Corporation has agreed to administer the County's Restaurant Relief Grant Program -- including promotional activities, application reviews, grant disbursements and required reporting activities -- in accordance with the Maryland Department of Commerce-Montgomery County Grant Agreement governing the use of these funds.

The amended FY21 Operating Budget Resolution 19-472, Section G, FY21 Designation of Entities for Non-Competitive Contract Award Status will read as follows:

The Office of the County Executive (CEX) will establish a contract with the Montgomery County Economic Development Corporation in the amount of \$4,938,298. The purpose of this contract will read as follows, "Develop and administer additional funds for the Montgomery County Restaurant Relief Grant Program in accordance with State guidelines and requirements."

MODIFICATION TO GRANT AGREEMENT

MODIFICATION TO GRANT AGREEMENT (this "Modification") is entered into as of the ____ day of _____, 20__, by and between the **DEPARTMENT OF COMMERCE**, a principal department of the State of Maryland (the "Department"), and **Montgomery County MARYLAND**, a body politic and a political subdivision of the State of Maryland ("Grantee").

RECITALS

The Department and Grantee entered into a Grant Agreement dated November 16, 2020 (the "Grant Agreement"), pursuant to which the Department approved a grant to Grantee (the "Grant" or "Grant Funds"), to enable Grantee to make grants to restaurants within Grantee's jurisdiction to promote and encourage stabilization within the hospitality and restaurant industry, all as more fully described in the Grant Agreement (the "Program").

In recognition of the continuing challenges faced by the hospitality and restaurant industry, Grantor has made available additional funding for the Program.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth in the Grant Agreement and in this Modification, the parties agree as follows:

1. Subject to Grantee's continued compliance with the provisions of the Grant Agreement and to Sections 2 and 3 of this Modification, the Department agrees to increase the amount of the Grant to Grantee by an additional \$4,938,298.
2. Grantee shall request disbursement of the additional Grant Funds by using the request for Disbursement form attached as Exhibit D to the Grant Agreement.
3. Section 1(b) (v) of the Grant Agreement is hereby modified to extend the date by which Grantee must disburse Grant Funds, including the additional Grant Funds, from December 31, 2020, to March 31, 2021.
4. The due date of the report describing the use of the Grant Funds (Exhibit C) is extended from February 28, 2021 to June 30, 2021.
5. Exhibit A of the Grant Agreement is hereby amended to incorporate Grantee's application for the additional Grant Funds.
6. In all other respects, except as expressly modified, amended or corrected by this Modification, the provisions of the Grant Agreement remain in full force and effect between the parties.

Award Status

Background

1. Section 308 of the Montgomery County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
2. On March 11, 2020, the World Health Organization declared coronavirus COVID-19 a pandemic and it has spread rapidly throughout the world. As of November 1, 2020, the Montgomery County Government COVID-19 data dashboard reported 26,114 confirmed cases and 833 confirmed deaths in the County. To slow the spread of the disease, Maryland Governor Hogan first declared a State of Emergency on March 5, and has issued several Executive Orders with actions that include, but are not limited to: closing schools; prohibiting activities by non-essential businesses that restrict traditional on-site operations; limiting the number of people that can gather; and closing all gyms, movie theaters, and bars and restaurants (excluding carryout and delivery service).
3. The efforts to contain the spread of the disease and the disease itself continues to have a crippling impact on Montgomery County's local business community, in particular its restaurants and related food service facilities.
4. On December 17, Maryland Governor Hogan announced an additional \$180 million supplement to the 'Maryland Strong: Economic Recovery Initiative,' which will provide funding from the State's Rainy Day Fund to directly assist restaurants, small businesses, local entertainment venues, arts organizations, and Main Streets across the state. Thirty million dollars of this initiative has

been earmarked for direct relief for restaurants, funds that have been allocated to local jurisdictions to administer and disburse.

5. Montgomery County has entered into an agreement with the Maryland Department of Commerce for a grant in the amount of \$4,938,298. The purpose of this financial grant is to enable Montgomery County to make grants to restaurants within the County in order to promote and encourage stabilization within the restaurant and hospitality industry.
6. The State grant agreement stipulates that Montgomery County may permit restaurants to fund the following expenses from grant proceeds provided by the State:
 - Working capital, such as rent, payroll, and job training;
 - Purchase of equipment and services to expand outdoor dining, such as tents, heaters, warmers, and carts;
 - Infrastructure improvements, such as HVAC system upgrades;
 - Technology to support carryout and delivery;
 - Purchase of PPE and disposable food containers and utensils;
 - Sanitization services; and
 - Any other costs permitted under a COVID-19 restaurant assistance program offered by Montgomery County.
7. The Montgomery County Economic Development Corporation (MCEDC), collaborating with the County's Business Advancement Team, will administer the County's Restaurant Relief Grant Program, including promotional activities, application reviews, grant disbursements, and required reporting activities in accordance with the Maryland Department of Commerce-Montgomery County Grant Agreement governing the use of these funds.
8. MCEDC will partner with the County and other economic development partners to broadly market the initiative to the County's business community.
9. The Council through this special appropriation is creating the Montgomery County Restaurant Relief Grant Program. Local entities eligible to receive a financial award up to \$10,000 include: restaurants, food trucks, caterers, wineries and breweries that directly provide food service, individual locally-owned franchised restaurants, and restaurants in hotels and in arts/entertainment/recreational facilities. An entity will be eligible to receive assistance from the Restaurant Relief Grant Program if it: 1) has its principal place of business in Montgomery County; 2) is in good standing with the State of Maryland; 3) requires financial assistance to pay for the expenditures permitted by the State through its appropriation to Montgomery County; and 4) has not used, and will not use, funds received from this grant program for the same purpose as funds received through other Montgomery County grant programs. A business that has permanently closed will not be eligible for the Restaurant Relief Grant Program.

10. A Fiscal Year 2021 Operating Budget is requested for the Montgomery County Economic Development Corporation Non-Departmental Account:

11. Section 11B-14 (a) (4) of the Montgomery County Code states that “a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council.” The result of this action is to amend the Fiscal Year (FY) 2021 Designation of Entities for Non-Competitive Contract Award status to include a new contract with MCEDC to develop and administer the Montgomery County Restaurant Relief Grant Program.
12. The Chief Administrative Officer has determined that funding for the contract with this entity serves a public purpose and that such an expense would be in the public interest.
13. Notice of public hearing was given and a public hearing was held.

Action

The County Council for Montgomery County, Maryland approves the following resolution:

A special appropriation to the FY21 Operating Budget for the Montgomery County Economic Development Corporation Non-Departmental Account:

This special appropriation must be used for the Restaurant Relief Grant Program under the guidelines described in paragraphs 6 through 9.

This resolution amends Resolution 19-472, Section G, FY21 Designation of Entities for Non-Competitive Award Status to allow the Office of the County Executive to enter into a contract with the Montgomery County Economic Development Corporation with the purpose to “Develop and administer the Montgomery County Restaurant Relief Grant Program in accordance with State guidelines and requirements.”

This appropriation is needed to act without delay in the public interest.
