# **DESCRIPTION/ISSUE**

Resolution 19-872, Section G authorizes non-competitive contract awards. The Chief Administrative Officer (CAO) is recommending amendments for new contracts with four entities. No new appropriation is required.

- Contract with Corporation for Supportive Housing, Inc. will provide project evaluation and training to support Housing First. This contract is grant funded.
- Contract with the YMCA of Metropolitan Washington for family strengthening and intervention in Germantown, Montgomery Village, and Wheaton/Silver Spring areas to address service gaps to families in the Street Outreach Network of the Safe Space program.
- Contract with the Collaboration Council to implement *The Basics* program to support families with young children birth through age 5.
- Contract with Family Services, Inc., for *LENA Start* to increase language development for children birth through age 3.

### Background

- 1. Section 11B-14 (a) (4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and proposed contractor has been identified in a grant or appropriation resolution approved by the Council." The result of this action is to amend the Fiscal Year (FY) 2022 Designation of Entities for Non-Competitive Contract Award status resolution to include the entities listed below.
- 2. The Chief Administrative Officer has determined that funding for the contracts with these entities serves a public purpose and that such an expense would be in the public interest.
- 3. The Department of Health and Human Services will establish a new contract with Corporation for Supportive Housing, Inc. in the amount of \$80,000, "To provide project evaluation, training and support to align with Housing First principles and best practices."
- 4. The Department of Health and Human Services will establish a new contract with YMCA of Metropolitan Washington in the amount of \$300,000, "To establish a family strengthening and intervention program in the Germantown and Wheaton/Silver Spring Area to address service gaps to families participating in the Street Outreach Network of Safe Space Program."
- 5. The Department of Health and Human Services will establish a new contract with Montgomery County Collaboration Council for Children, Youth and Families, Inc. in the amount of \$150,000, "To implement *The Basics* program to build community partnerships to support families with young children, birth through age five."
- 6. The Department of Health and Human Services will establish a new contract with Family Services, Inc. in the amount of \$33,169, "To implement *LENA Start*, a program to increase language development for children birth to age three."

### **ACTION**

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 19-872, Section G, FY22 Designation of Entities for Non-Competitive Contract Award. Establish a new contract with Montgomery County Collaboration Council for Children, Youth and Families, Inc. in the amount of \$150,000 with the stated purpose of "To implement *The Basics* program to build community partnerships to support families with young children, birth through age five."

Establish a new contract with Family Services, Inc. in the amount of \$33,169 with the stated purpose of "To implement *LENA Start*, a program to increase language development for children birth to age three."
