# **DESCRIPTION/ISSUE**

There is an increase need to strengthen the quality of community behavioral health treatment services. The need has grown during the COVID-19 pandemic. These funds will be used to support intervention services, especially for children and adolescents as they return to school and referrals for services increase. It will support creation of an interim stabilization center as an alternative to emergency rooms and incarceration.

### **SUMMARY OF KEY DISCUSSION POINTS**

- The Department of Health and Human Services' Crisis Center is available 24/7 by telephone or walk-in for Montgomery County residents experiencing a mental health and/or substance use related crisis. The Crisis Center provides 24/7 telephone and walk-in services that are culturally appropriate, and they provide person- and family-centered behavioral health care services.
- The SAMHSA grant will allow DHHS to further expand the number of Mobile Crisis Outreach
  Teams (MCOTs) increasing the number of intervention requests that can receive this response.
  It will also increase the ability to maintain contact with, monitor, and refer more crisis clients to
  ensure they end up in a safe and appropriate service environment or recover from their crisis.
  The interim stabilization center and increased services will divert more people from emergency
  rooms and incarceration.
- The grant will fund peer support as a component of the MCOTs. Peer-support is a key component of the County's strategy as the lived experience of recovery from mental illness and/or addiction is powerful proof that there is hope for individuals in crisis.

I am recommending a special appropriation to the FY22 Operating Budget of the Department of Health and Human Services (DHHS) in the amount of \$1,915,270 for the Substance Abuse and Mental Health Services Administration (SAMHSA) Center for Crisis 2 Connection Grant Award. This appropriation will fund activities that support the County's initiatives around strengthening community mental health centers.

This increase is needed to restore access to and strengthen the quality of community behavioral health treatment services available prior to the COVID-19 pandemic. This funding will support intervention services interrupted by the COVID-19 pandemic, especially for children and adolescents as they return to school and referrals rise, and to create an interim stabilization center as an alternative to emergency rooms and incarceration that also addresses increases in mental health and substance use crises fueled by the COVID-19 pandemic.

I recommend that the County Council approve this special appropriation in the amount of \$1,915,270 and specify the source of funds as Federal Grant funds.

## **Background**

- 1. Section 308 of the County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
- 2. The County Executive has requested the following FY22 Operating Budget appropriation increase for the Department of Health and Human Services:

- 4. The Source of funding for this appropriation is from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA) Center for Crisis 2 Connection: Expanding the Care Continuum into the Community Grant Award. The funds will support the County's initiatives to strengthen community mental health centers.
- 5. Notice of a public hearing was given and a public hearing was held.
