State Legislation

1. <u>HB 24</u> / <u>SB 4</u>: Cybersecurity Scholarship Program – Alterations and Maryland Cybersecurity Loan Assistance Repayment Program – Establishment (Senator Hester)

Bill summary: The bills expand the existing Cybersecurity Public Service Scholarship Program (Scholarship Program) and create a new Cybersecurity Loan Assistance Repayment Program (Loan Repayment Program). The Scholarship Program is expanded to allow a full-time student to hold an award for a maximum of 3 years, rather than 2 years, and to allow a part-time student to hold an award for a maximum of 6 years. The Office of Student Financial Assistance at the Maryland Higher Education Commission is given authority to determine prorated awards for part-time students. Currently, an award recipient is required to work for a State agency in a cybersecurity field for the same number of years that the recipient held the award. The bills allow a recipient to meet the work requirement through employment in the cybersecurity field

with a county or municipal government, public high school (including teaching), or community college (including teaching). The new Loan Repayment Program will assist in the repayment of higher education loans for individuals who are employed in the cybersecurity field with the same employers who qualify under the Scholarship Program. The Office of Student Financial Assistance is required to adopt regulations governing the application process, system of prioritizing applicants, and maximum amount of loan repayment award.

2. <u>HB 685</u> / <u>SB 448</u>: Education – Regional Resource Centers and Libraries – Funding (Delegates C. Branch, Amprey, Attar, Ebersole, Foley, Henson, Jackson, D. Jones, R. Lewis, McIntosh, Palakovich Carr, and Smith; Senator King)

Bill summary: The bills increase per capita State funding for public libraries and regional resource centers in each of the next five fiscal years. For county libraries, the per capita funding increases from \$17.10 per resident in fiscal 2022 to \$20.00 per resident in fiscal 2027 and each year thereafter. In fiscal 2022, the Montgomery County public library system received \$3.5 million in State aid.

3. <u>HB 425</u> / <u>SB 387</u>: *Public Safety – Untraceable Firearms* (The Speaker (By Request - Office of the Attorney General) and **Delegate** Lopez; **The President** (By Request - Office of the Attorney General) and **Senator** Lee)

Bill summary: The bills expand the definition of "firearm" to include an unfinished frame or receiver, described as a forged, cast, printed, extruded, or machined body or similar article that has reached a stage where it could be used as parts of a functional firearm and is marketed or sold as such, once completed, assembled, or converted. The bills prohibit purchasing, receiving, selling, offering to sell, or transferring an unfinished frame or receiver without a serial number imprinted by a federally licensed firearms manufacturer or importer. Also, beginning January 1, 2023, they prohibit possessing any firearm without a serial number imprinted by a federally licensed firearms manufacturer or importer, as prescribed in the bills. Any person convicted of a violating these provisions is subject to up to three years in prison and a fine of up to \$10,000. The effective date of HB 425/SB 387 is June 1, 2022.

4. <u>HB 517</u> / <u>SB 460</u>: Consumer Health Access Program for Mental Health and Addiction Care – Establishment (Delegate R. Lewis; Senator Augustine)

Bill summary: The bills create a collaborative program between the University of Maryland Baltimore School of Social Work Center for Addiction Research, Education, and Services (the "incubator" entity under the bills); a private, community-based non-profit organization or public university located in Maryland (the "hub" entity); and private, community-based non-profit organizations located in eight regions across the state (the eight "spoke" entities).

The incubator and hub entities administer the Consumer Health Access Program for Mental Health and Addiction Care (the Program) and its funding. Under the bills, the Governor is required to appropriate \$1M for the Program for fiscal years 2024-2026 and the Program may seek additional private or public funding.

The Program utilizes a hub and spoke model to help consumers (both uninsured and those with private or public insurance) and health care providers navigate and resolve issues related to health plan enrollment and coverage, consumer access to mental health and substance use disorder services, and enforcement of rights under mental health parity laws. The Program will be a three-year pilot, and will consist of:

- Outreach, education, and assistance to consumers regarding insurance enrollment and access to mental health and substance use disorder treatment;
- a toll-free helpline and online assistance portal available to consumers, health care providers and individuals within the State's behavioral health crisis response system to enable access to the services of the Program;
- assistance with and representation of consumers in the filing of complaints;
- coordination with state agencies to promote greater access to mental health and substance use disorder services and resolution of consumer complaints;
- data collection and analysis of program utilizers to address disparities in accessing mental health and substance use disorder services by race, ethnicity, and gender;
- identifying trends and gaps in coverage of and access to mental health and substance use disorder services and violations of the Mental Health Parity and Addiction Equity Act;
- recommending policies and practices to resolve deficiencies in coverage and access to services;
- conducting advocacy with State agencies and the General Assembly to address systemic issues; and
- issuing an annual report.

The eight spoke entities will be contracted with the hub entity to provide consumer assistance services. The hub and incubator entities will operate the Program, including establishing the Program and facilitating its implementation. The bills have considerations for providing services that meet the cultural and linguistic needs of consumers and that utilize best practices such as peer service delivery, multiple service delivery modalities, and ensuring the consumer assistance services include and represent the diversity of the population of the State across many demographics. The bills empower the Program to obtain appropriate records from insurers, providers, and state agencies upon consent of the consumer as necessary to enable the Program to assist with consumer complaints.

These bills touch on the County priority to support all efforts to implement a Statewide plan to address the shortage of inpatient mental health treatment beds.

5. <u>HB 533</u> / <u>SB 523</u>: Occupations and Professions – Licenses, Certificates, and Registration – Immigrants (Delegates Pena-Melnyk, B. Barnes, Lehman, Love, Shetty, Terrasa, and Valentino-Smith; Senator Kagan)

Bill summary: The bills prohibit a State occupational or professional licensing board from denying an occupational or professional license, certification, or registration to an immigrant if the individual otherwise meets all educational, training, or professional requirements for licensure, certification, or registration.

These bills further the County priority to increase the number of linguistically and culturally competent health care, behavioral health, and social services professionals, including efforts to reduce unnecessary professional licensure barriers.
