# **DESCRIPTION/ISSUE**

Montgomery County continues to support the vaccination of County residents against COVID-19 through clinics and special health initiatives. Ongoing funding is needed to continue to expand existing infrastructure and ongoing efforts to increase vaccinations, reduce hesitancy, and reach minority residents with culturally and linguistically appropriate services to reduce disparities.

#### SUMMARY OF KEY DISCUSSION POINTS

- The COVID Mass Vaccination CARES Grant is awarded to the County by the Maryland Department
  of Health's Prevention and Health Promotion Administration. The source of funding to the State
  is the Federal Department of Health and Human Services, Center for Disease Control and
  Prevention (CDC).
- The February 23, 2022, DHHS Pulse Report says that as of February 19, 2022, at least 85% of the
  total population has received at least two doses of vaccine; and 52% of the fully vaccinated
  population has received a booster. However, the first dose rate for non-Hispanic Black residents
  continues to be lower than for non-Hispanic Whites and there are several census tracts, primarily
  in the east county and Gaithersburg/Germantown area that have below average first dose rates.

I am recommending a special appropriation to the FY22 Operating Budget of the Department of Health and Human Services (DHHS) in the amount of \$2,109,404 for COVID Mass Vaccination CARES grant. This appropriation will fund COVID-19 vaccination implementation activities. The source of funding for this appropriation is from the Maryland Department of Health, Prevention and Health Promotion Administration. This grant is funded through the Federal Department of Health and Human Services, Centers for Disease Control and Prevention (CDC).

This increase is needed to support the administering of COVID-19 vaccines in Montgomery County. The funds will further expand existing infrastructure, engage in partnerships, and implement strategies to reach affected populations, such as those who are vaccine hesitant, those who are in racial and ethnic minority populations, and those living in rural communities.

I recommend that the County Council approve this special appropriation in the amount \$2,109,404 and specify the source of funds as State funds.

#### **Background**

- 1. Section 308 of the Montgomery County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
- 2. The County Executive has requested the following FY22 Operating Budget appropriation increases for the Department of Health and Human Services.
