- The FY23-28 Capital Improvements Program (CIP) as submitted by M-NCPPC consists of 41 projects: one new project and 40 ongoing projects.
- The County Executive (CE) recommends funding at \$254.5 million, which is a \$14.9 million (6.2 percent) increase from the previously approved CIP. However, more than half of this increase (\$8.8 million) is proposed to fund the Commission's work on behalf of the County toward the County's MS4 permit.

- The Executive's recommended budget (excluding the additional funding earmarked for the County's MS4 permit) represents a 2.5 percent increase over the amended FY21-26 CIP, and is 7.3 percent (or \$19.4 million) less than the budget requested by M-NCPPC.
- The Executive recommends an Affordability Reconciliation Project Description Form (PDF) that reduces Current Revenue expenditures by almost \$5 million and Government Obligation (GO) Bond expenditures by \$14.4 million (totaling \$19.4 million). The Reconciliation PDF does not indicate where the reductions should be made.

### **COMMITTEE RECOMMENDATIONS (BY PROJECT)**

- Approve one new project, Park Acquisitions, which replaces two existing projects, Park Acquisitions: Local Parks and Park Acquisitions: Non-Local Parks to aid in funding flexibility.
- Add General Obligation (GO) Bond funding to the Ballfields Initiative project and defer decision regarding Community Use of Public Facilities (CUPF) funds until Operating Budget discussions.
- Approve CE recommendation to add \$8.8 million to the Stream Protection: SVP project under long-term financing.
- Retain original M-NCPPC requested funding for the Brookside Gardens Master Plan Implementation, S. Germantown Recreational Park: Cricket Field, and Blair HS Field Renovation and Lights projects.
- Approve modifications to the following projects: Facility Planning: Non-Local Parks, Legacy Open Space; PLAR: NL - Minor Renovations; Wheaton Regional Park Improvements; and Northwest Branch Athletic Area, offered as non-recommended reductions/delays beyond the six-year CIP by M-NCPPC to meet the Executive's Affordability Reconciliation PDF.
- Approve delay in funding for the following projects: PLAR: LP Resurface Lots and Paths; Ovid Hazen Wells, and PLAR:NL – Play Equipment, offered as non-recommended changes by M-NCPPC to meet the Executive's Affordability Reconciliation PDF. These delays retain total funding over the six-year period.

### **OTHER ISSUES**

• The Committee agreed to defer the decision regarding Community Use of Public Facilities (CUPF) funds to support the Ballfield Initiatives project until Operating Budget discussions.

SUBJECT: M-NCPPC FY23-28 Capital Improvements Program (CIP)

PURPOSE: Worksession: straw vote expected

The Maryland-National Capital Park and Planning Commission (M-NCPPC) Capital Improvements Program (CIP) request for FY23-28 is \$265 million, an increase of \$25.4 million (10.6 percent) over the amended FY21-26 CIP (\$239.6 million). The FY23-28 CIP, as submitted by M-NCPPC, consists of 41 projects: one new project and 40 ongoing projects. The County Executive's recommended M-NCPPC budget is \$254.5 million, a 6.2 percent increase from the previously approved budget. However, more than half of this increase is proposed to fund the Commission's work on behalf of the County toward the County's MS4 permit. The Executive's recommended budget (excluding the additional funding earmarked for the County's MS4 permit) represents a 2.5 percent increase over the amended FY21-26 CIP, and is 7.3 percent (or \$19.4 million) less than the budget requested by M-NCPPC.

### SUMMARY OF PHED COMMITTEE RECOMMENDATIONS

The Planning Board Chair's transmittal letter is attached at ©1-16. It describes how this CIP is constructed, its emphasis on maintaining and enhancing the County's existing park system, with only one new project being requested. The Executive's recommendations are attached at ©17-30. Project Description Forms (PDFs) for all M-NCPPC projects are attached at ©31-110 (in alphabetical order, first for acquisition, then development projects). The Department of Parks' response to how they would fund the Executive's Recommendation by project is attached at ©111-132. A letter from Councilmember Rice can be found on ©133.

For the FY23-28 CIP, the Executive recommends modifications to two existing projects: Stream Protection: SVP and Urban Park Elements. As noted above, the Executive recommends an additional \$8.8 million to the Stream Protection: SVP project to reflect work M-NCPPC will do toward the County's MS4 permit. For the Urban Parks Element project, the Executive is recommending a two-year delay in funding for a dog park in Norwood Park, suggesting additional time is needed to consider alternative locations and community concerns. The two-year delay shifts \$500,000 in M-NCPPC Bonds from FY23 to FY25. In addition, the Executive recommends an Affordability Reconciliation PDF that reduces Current Revenue expenditures by almost \$5 million, reduces Government Obligation (GO) Bond expenditures by \$14.4 million (totaling \$19.4 million), and recommends deferring \$105,000 in M-NCPPC Bonds from FY25 to FY26 (\$68,000) and FY27 (\$37,000). The Reconciliation PDF does not indicate where the reductions should be made; however, the Executive does note that current revenue increases for facility planning for the Long Branch Area Parks Initiative included in the Facility Planning: Non-Local Parks project in FY24 should remain.

This memorandum is organized as follows: Section I describes new projects; Section II discusses existing projects changed since the amended FY21-26 CIP. This section includes an evaluation of the Executive's proposed increase to the Stream Protection: SVP project and the delay recommended for the Urban Park Elements project; Section III presents those projects that Staff believes do not require a project-by-project review by the Committee (as these are previously-approved projects with no significant changes<sup>5</sup>); Section IV lists, for reference, projects that are not recommended for funding during the six-year period, and Section V examines the Executive's Affordability Reconciliation PDF and the Parks Department's non-recommended reductions offered to meet it.

### I. NEW PROJECTS

### **Park Acquisitions**

The increase in the FY23-28 CIP over the amended FY21-26 CIP includes only one new capital project, Park Acquisitions, which is really a combination of two existing projects, Acquisitions: Local Parks and Acquisitions: Non-Local Parks. The Park Acquisitions project, as proposed, is revenue neutral. It combines the funding, expenditures, and appropriation requests from Acquisition: Local Parks and Acquisition: Non-Local Parks into one CIP project starting in FY23 and moving forward.

### II. PROJECTS THAT CHANGED

The Council received quite a bit of testimony regarding the Parks budget, practically one-third of all CIP testimony was related to park facilities. Most advocates requested restoration of the full requested CIP, expressing enthusiastic support for the entire park system. More specifically, however, residents requested restoration of funding to improve and maintain County trails, athletic fields, ball courts, and storm water management projects.

**Description:** This project addresses countywide ballfield needs by funding ballfield-related improvements on parkland, school sites, and other public sites. Improvements may include, but are not limited to, ballfield lighting, irrigation, drainage improvements, bleachers, fencing, backstops, soil

improvements, turf and infield establishment/renovation, reconfigurations, program support elements, and field upgrades. The increase in funding for this project is for two additional years of funding.

**Testimony:** The Council received testimony advocating for continued funding for ballfield renovation and maintenance.

**Council Staff comment:** Typically, given the nature of the proposed change in funding, this project would be grouped with consent items. However, funding of \$300k/year for FY23-28 is from CUPF revenue. In FY21 and FY22, CUPF revenue funding was replaced with GO Bond funding due to the impact of COVID-19. The discussion of CUPF revenue is typically discussed as part of the Operating Budget review.

Committee Recommendation: Increase GO Bond funding by \$300k/year and defer CUPF funding decision until review of the Operating Budget.

Projects include a variety of improvements at local parks, such as new picnic shelters, seating, courts, hardscape, activation support features, parking, signage, landscaping, walkways, exercise equipment, site amenities, retaining walls, dog exercise areas, park management support elements, utilities, etc. Increase of \$90k-\$136k/year in FY23-26 compared to current CIP and add two fiscal years of funding at \$500/year.

This project makes corrective improvements to damaged stream channels, floodplains, and tributaries in stream valley parks and constructs new stormwater management (SWM) facilities and associated riparian enhancements to improve watershed conditions. Stream protection projects must be examined from a watershed perspective to identify/control the source of problems. ### V. IMPACT OF COMMITTEE RECOMMENDATION ON AFFORDABILTY PDF

As noted at the beginning of this staff report, the M-NCPPC CIP request for FY23-28 is \$265 million, an increase of \$25.4 million (10.6 percent) over the amended FY21-26 CIP (\$239.6 million). The County Executive's recommended M-NCPPC budget is \$254.5 million, a 6.2 percent increase from the previously approved budget. However, more than half of this increase is proposed to fund the Commission's work on behalf of the County toward the County's MS4 permit. The Executive's recommended budget (excluding the additional funding earmarked for the County's MS4 permit) represents a 2.5 percent increase in the FY23-28 CIP over the amended FY21-26 CIP, and is 7.3 percent (or \$19.4 million) less than the budget requested by M-NCPPC.

To address the budget gap, the Executive recommends an Affordability Reconciliation PDF that reduces Current Revenue expenditures by almost \$5 million, reduces GO Bond expenditures by \$14.4 million, and recommends deferring \$105,000 in M-NCPPC Bonds from FY25 to FY26 (\$68,000) and FY27 (\$37,000). For reference, the Executive's recommendations are attached at © 17-30. And the Department

of Parks' response to how they would alter their funding request to meet the Executive's Recommendation is attached at © 111-132. A letter from Councilmember Rice is attached on © 133.

### 1. Deferral of \$105k in M-NCPPC Bonds

To address the Executive's recommended deferral of M-NCPPC Bonds, the Parks Department proposed a modification to PLAR: LP – Resurface Lots and Paths project. The proposed change results in a shift in \$105k in M-NCPPC Bond funding from FY25 to FY26 (\$68k) and FY27 (\$37); however, the M-NCPPC Bond funding for these years still results in an increase over the currently amended FY21-26 CIP.

Committee Recommendation: Support the deferral of M-NCPPC Bond expenditures for the PLAR: LP project to address the Affordability PDF.

### 2. Reduction in Current Revenue and GO Bond Funding

In putting forth proposed reductions to meet the CE's budget, the Board expressed concern with the impact these cuts would have on Parks' ability to adequately support its programs. Emphasizing that the CIP transmitted to the Council in November represents the minimum they believe is necessary to adequately support the park system, to meet the Executive's proposed reduction in Current Revenue and GO Bond expenditures, the Department proposed a list of reductions and included restorations to those proposed reductions (and delays) in prioritized tiers (see ©111-132)

Restoration of funding for the Park's CIP request comprised almost one-third of the testimony on the County's CIP. Recognizing that there are many competing priorities, and that the County continues to face uncertain economic conditions, reducing County expenditures is a prudent course to take; however, this past year has again demonstrated the importance of parks to the mental, physical, and emotional well-being of County residents. Parks provide a safe and healthy escape during challenging times, and our County has relied on them more than ever over the past two years.

Below is the list of Committee-recommended changes in funding and the impact on the Affordability Reconciliation PDF targeted reductions.

The Committee, recognizing the importance of level-of-effort projects did not support the full reduction to PLAR: NL-Minor Renovations as this capital project helps maintain the County's existing park

system by bringing renovation and maintenance efforts into check, meeting mandates, and addressing the additional (and rising) cost of providing an award-winning Park system. The Committee noted that should funds be available, they would restore the \$980k to the PLAR: NL – Minor Renovations project.

The above changes also include a delay in funding for the Northwest Branch Athletic Area (\$500k), Ovid Hazen Wells (\$580k) FY25 to FY26, and PLAR:NL – Play Equipment (\$200k) FY25 to FY26. It is important to note that M-NCPPC assured the Committee the delay to Ovid Hazen Wells would impact project completion by only 3 months.

In testimony received by Council – many Parks projects are never mentioned; however, Brookside Gardens, Wheaton Regional Park, and the South Germantown Town Recreational Park Cricket Field all received testimony requesting support for continued or increased funding of these facilities. The Council also received support for the Blair HS Field Renovation and Lights project, noting the importance of such a facility to eastern Montgomery County.

The Committee did not support proposed reductions to the Brookside Gardens Master Plan Implementation project and the Blair HS Field Renovation and Lights project. Nor did it support further reductions to Wheaton Regional Park Improvements or a delay to the South Germantown Park Cricket Field.

The Maryland-National Capital Park and Planning Commission is pleased to submit its proposed FY23-28 Capital Improvements Program (CIP) for the County's nationally recognized Gold Medal park system<sup>1</sup>. We pride ourselves as stewards of a system that offers recreational and educational opportunities, enhances property values, builds community, and protects the natural environment.

While we have maintained the park system to a high level over many years, our facilities continue to age. In response to increasing demands and deteriorating infrastructure, this CIP places a greater emphasis on maintaining and enhancing our existing park system and spending precious dollars where they are needed most.

You will find that the Parks CIP is in line with the County's Policy Goals (the Five E's):

- Educational Opportunities for All the parks are the living, breathing environmental classroom for all county residents.
- Equity the Commission has furthered its work to deliver projects where they are needed most by viewing our communities through a more focused equity lens and using our Equity Focus Area Tool (for more information please see **Exhibit A**).

This request includes the Park Refresher CIP project that provides smaller scale renovations and improvements more quickly than the traditional model of larger scale renovations that otherwise might have to wait years to get through facility planning and obtain funding.

Programming projects in the current tight fiscal context requires relying heavily on the priorities including:

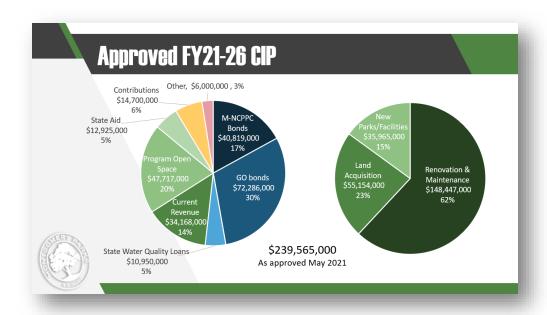

- Responding to fiscal constraints identified by the Planning Board, County Executive, and the County Council throughout the CIP process

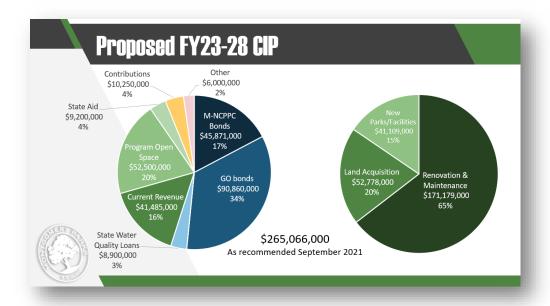
Within this framework, the Planning Board has also addressed:

- Promises and commitments made to county residents
- Preserving funding increases to priority CIP projects such as Planned Lifecycle Asset Replacements, Park Refreshers, Trails Renovations, and Ballfields

### **Summary of the CIP**

Below you will find summary charts comparing the currently approved FY21-26 CIP to the Department's Submission for the FY23-28 CIP<sup>2</sup>. The overall CIP request approved by the Planning Board in October brings the CIP to \$265,066,000 for FY23-28. This is a 10.6% increase above the currently approved FY21-26 CIP of \$239,565,000. Included in the FY23-28 CIP are appropriation requests that collectively make up the FY23 Capital Budget of \$45,131,000.

### **Funding Sources**

While developing this CIP, the Board continued its effort to better prioritize projects to maximize our investment in the county's park system. This included incorporating state funding from Program Open Space and contributions from private partners that augment local public funding. In the proposed CIP, the Commission has pursued or will pursue \$80,850,000 or 30.5% in non-County and non-Commission funds.

As we transition from the current FY21-26 CIP into FY23-28, certain funding sources increase while others decrease. This is because funding for FY21-22 is no longer part of the CIP, while funding for FY27-28 is added to the CIP, and funding for the middle years, FY23-26, is often adjusted as well.

This CIP assumes <u>increases</u> in appropriations and revenues during the years coming from the following sources:

### **Expenditure Categories**

The Parks CIP projects generally fit in one of the following categories:

- <u>Renovation and Maintenance</u> repair, renovation, and lifecycle replacement of existing park facilities and supporting infrastructure. This includes natural, cultural, and historical resources on parkland.
- New Parks and Park Facilities responding to unmet park and recreation needs.
- <u>Land Acquisition</u> continued commitment to expansion of parkland through Legacy Open Space and park acquisition programs.

The recommended FY23-28 CIP has a strong focus on stewardship of existing resources and infrastructure but also maintains a balanced response to the growing population and demands of the county. The Renovation and Maintenance category is the largest piece of the CIP, underlining the importance of maintaining and/or renovating existing infrastructure, continuing service delivery, and reducing maintenance costs that affect the operating budget.

Proposed new projects are minimal. The Park Acquisitions PDF is a new capital project but is revenue neutral. This project simply combines the funding, expenditures and appropriation requests from two existing acquisition capital projects (Acquisition: Local Parks and Acquisition: Non-Local Parks) into one CIP project for FY23 and moving forward.

Standalone projects in the current CIP that are not yet under contract and continue into the new CIP are candidates for budget increases due to inflation. However, for affordability reasons and to offset some of the increases that we are requesting in other areas of the CIP, we have opted not to escalate this small handful of projects that otherwise would have increased the CIP.

#### **CIP Evaluation Process and Guiding Documents**

Developing the CIP is complex due to the various stakeholders involved in the process. However, all activities fall into at least three categories: Project origination, prioritization of projects, and consideration of constraints. This process is outlined in more detail in **Exhibit E**.

### **CIP Projects: Acquisition and Development**

The Parks CIP consists of two broad categories, Acquisition Projects and Development Projects.

### **Land Acquisition Projects**

The parks acquisition program purchases lands that are critical to expanding the recreational, conservation, and urban parks that serve the growing and changing population of Montgomery County. While it is important to keep adequate funds available across the various acquisition projects to

purchase key properties, the requested funding levels may not be adequate for certain significant and expensive park acquisitions, especially for urban land. When appropriated funds are not adequate to achieve a specific park acquisition, the Department will submit a supplemental appropriation request to the County Council. Since the costs and timing of the most expensive urban park acquisitions are unknown, the supplemental appropriation process is a suitable tool to fund these projects.

#### **Park Acquisitions**

As mentioned earlier, the Park Acquisitions PDF is a new capital project but is revenue neutral. This project simply combines the funding, expenditures and appropriation requests from two existing acquisition capital projects (Acquisition: Local Parks and Acquisition: Non-Local Parks) into one CIP project for FY23. In the meantime, existing appropriations through FY22 will be spent down in the following projects that are marked as pending closeout in the interim:

#### **Acquisition: Local Parks**

The Local Park Acquisition PDF identifies capital expenditures and appropriations for Community Use Parks, including neighborhood, local, neighborhood conservation, and community use urban parks as defined by the 2017 PROS Plan. The funding source for this project is primarily Program Open Space with a small amount of M-NCPPC Bonds for program support expenses.

### Acquisition: Non-Local Parks

The Non-Local Park Acquisition PDF identifies capital expenditures and appropriations for acquisitions of land for countywide parks, including regional, recreational, special, stream valley and conservation parks. This PDF also is used for acquisition of Countywide Urban Parks as defined in the 2017 PROS Plan, including Civic Greens, Countywide Urban Recreational Parks, Urban Greenways, and Plazas. The PDF provides latitude to acquire properties consistent with master plans and Commission policies as properties become available or are required to meet immediate needs. The funding source for this project is primarily Program Open Space with a small amount of Current Revenue for program support expenses.

### Advanced Land Acquisition Revolving Fund (ALARF)

The Advanced Land Acquisition Revolving Fund (ALARF) was established in the Commission's CIP to enable acquisition of rights-of-way and other property needed for future public projects such as parks, road, etc. ALARF funds can only be spent on properties that are identified in an approved and adopted master plan for a public purpose. ALARF funding and tracking is managed in the operating budget, but a PDF is provided in the CIP because acquisitions are typically a capital expenditure. This PDF is intended to provide a snapshot of the ALARF funding. As of June 30, 2021, the balance in the ALARF account is approximately \$10.4 million. As land purchase contracts using ALARF are negotiated and approved by the Planning Board, the County Council will receive requests for approval of these expenditures. As the balance in the revolving fund drops below the level needed for priority acquisitions due to expenditures and diminishing land sales, the Commission may issue a bond sale in the future to replenish available funds.

#### Bethesda Park Impact Payment

This project will hold and spend Park Impact Payments (PIPs) submitted to M-NCPPC as a condition of Planning Board approvals of certain developments within the Bethesda CBD. The PIPs may be use for acquisition of parkland, renovation of existing parks, and development of new parks within the Bethesda CBD. To date, nearly \$18 Million in PIPs have either been approved or are anticipated in site plans by the Planning Board through FY23. The Parks Department will use these funds to support the priority park projects identified in the Bethesda Downtown Plan.

#### Mid-County Park Benefit Payments

In 2020, this was a new CIP project that will have \$3,500,000 of appropriation through FY24 to receive park benefit payments from developments in the White Flint, Grosvenor-Strathmore, and Rock Spring areas. In lieu of dedication of park land and as a condition of development approvals, the Planning Board may accept substantive contributions toward acquisition of new land to meet these master plan recommendations. These funds are intended to create new park resources, as opposed to the renovation/modification of existing parks. Funds that are allocated for planning, design, and construction of parks will be transferred to the appropriate development capital project within the CIP. Expenditures will be based on the park priorities within each of the master/sector plan areas, availability of land for acquisition, site improvement needs, and the Parks Departments' design and construction schedule.

#### Legacy Open Space

The Legacy Open Space (LOS) program was created to implement the Legacy Open Space Functional Master Plan (2001) by committing \$100M in funding to preserve the best remaining open spaces, watersheds, and historic properties across the county. Since its inception, the program has successfully protected over 3,850 acres through acquisition and has allowed the LOS program to leverage an additional \$16 million in non-County funding, including State and municipal funds and the direct donation of five properties (116 acres valued at over \$2.8 million) to the park system.

#### Legacy Urban Space

This project is funded with state Program Open Space and other grants is for the acquisition of valuable open space in the county's most densely populated areas. Envisioned at \$150 million over ten years, this project helps to implement the Energized Public Spaces Functional Master Plan methodology for more equitably linking parks to populations in urban areas and is modeled after the visionary Legacy Open Space capital project. Acquisitions will be prioritized based on multiple factors, including providing service to lower income and racially diverse areas, addressing the largest public space deficits, seizing on opportunity acquisitions, and locations of highest population growth and associated park needs. Sites within the EPS Study Area that are identified for park acquisition in other sector, master or functional plans also may be acquired with this PDF. The County Council encourages the Commission to seek supplemental appropriations if approved CIP funding is insufficient.

### **Development Projects**

The CIP contains several stand-alone projects, or distinct individual projects that generally are reviewed and approved by the Board as facility plans before the Council is asked to approve design and construction funds.

#### Level-of-effort Projects

In addition to stand-alone projects, the CIP also includes several level-of-effort projects that generally have a consistent and continuous level of funding from year to year and fund smaller sub-projects that do not require facility planning. While the Department evaluates and prioritizes the sub-projects within these PDFs with a particular focus on the first two years of the program, the Department may revisit and adjust priorities on an on-going basis. This is so that new sub-projects are prioritized and evaluated against existing projects.

The Board's continued shift toward renovation and maintenance projects in the CIP is mainly accomplished by using level-of-effort projects. Properly funded, these projects maintain the existing park system, bring life-cycle schedules into check, meet mandates and address the additional cost of doing business.

Unlike stand-alone construction projects where the County may factor in inflation with each CIP review, there is no policy that regularly recognizes natural cost increases in level-of-effort projects, leaving departments and agencies having to advocate continually for adjustments to the projects.

The level-of-effort development projects included in the CIP are as follows:

16. Trails: Natural Surface & Resource- based Recreation	Maintain overall 6-year funding levels.

17. Urban Park Elements	Six-year total increase of \$2.349M for new amenities within urban parks.
18. Vision Zero	Maintain overall 6-year funding levels for improvements to trails, roads, access routes to enhance safety and calm traffic.

The FY23-28 CIP addresses the critical needs of the county's park system. The development of the CIP was a comprehensive and heavily coordinated effort among many stakeholders, including the Planning Board, Parks staff, County, and public. Through this capital budget, the Commission seeks to adequately maintain our existing park system, conserve open space and valuable cultural resources, provide new recreational facilities, and preserve and enhance the environment. ## AGENCY DESCRIPTION

The Maryland-National Capital Park and Planning Commission (M-NCPPC) is a bi-county agency established by the State of Maryland in 1927 to prepare comprehensive land use and transportation plans as well as acquire, develop, maintain and operate a park system for Montgomery and Prince George's Counties. M-NCPPC is governed by a ten-member commission consisting of two five-member Planning Boards. The Planning Boards are appointed by and represent their respective counties.

The Montgomery County Planning Board oversees 36,991 acres of parkland and 422 parks and open space areas. Most of the County's park acreage is found in large Countywide (Non-local) Parks that serve all County residents. These include: Regional, Recreational, Special, Urban, Stream Valley, and Conservation Area parks. Residents can also enjoy many Community-Use (Local) Parks that are closer to home. These include: Urban, Neighborhood, Local, and Neighborhood Conservation Area parks. For information purposes, an outline of the Parks Classification System contained in the Master Plan for Parks, Recreation and Open Spaces (PROS) is provided at the end of this chapter.

# PROGRAM DESCRIPTION AND OBJECTIVES

The M-NCPPC's FY23-28 capital program request consists of one new project and 40 ongoing projects with expenditures in the six-year period. Included within these projects are two projects with multiple subprojects: Planned Life Cycle Asset Replacement: Non-local and Local.

The M-NCPPC Affordability Reconciliation Project (P871747) adjusts total M-NCPPC expenditures and funding to conform to the Executive's recommended funding levels, which are affordable within the CIP.

The section following this narrative only shows the project description forms (PDFs) for which the Executive recommends changes to the Montgomery County Planning Board's FY23-28 request. # CAPITAL PROGRAM REVIEW

## **M-NCPPC** Request

The Montgomery County Planning Board's capital program for M-NCPPC totals \$265.1 million, a \$25.5 million, or 10.6 percent increase, over the previously approved budget. This request had a strong focus on stewardship and support of the existing park system and core infrastructure, as well as a desire to respond to the needs of the County's diverse and growing population. Maintenance and renovation work includes school field renovations, Americans with Disabilities Act upgrades, stormwater improvements, and lifecycle replacements. Enhancements include completing construction on the Black Hill Regional SEED classroom, continuing construction on a second cricket field at the South Germantown Recreational Park, Bethesda Park acquisitions and

development, and improvements at Ovid Hazen Wells Park, Wheaton Regional Park, and urban parks. Funding was also requested for Vision Zero safety improvements and expansion of parkland through the Legacy Open Space initiative and park acquisition programs.

## **HIGHLIGHTS**

- Include \$3 million in new funding for Bethesda Park acquisition or improvements.
- Complete construction in the spring of 2023 on the Black Hill Regional Park SEED Classroom to convert a maintenance yard to
  an environmentally friendly educational site using the principles of Sustainable Education Every Day (SEED) Classroom design
  and construction. The building at Black Hill Regional Park is designed for net-zero energy and net-zero water and can help
  children learn how the building functions and better understand the flows of energy and water.
- Continue construction on the second phase of the South Germantown Cricket Field, which includes a full-sized cricket field, additional parking, amenities and irrigation.
- Renovate two fields at Blair High School for multiple sports for both school and community use.
- Fund enhancements for the Ovid Hazen Wells Recreational Park, which encompass the active recreation area in the park and the
  relocation of the Ovid Hazen Wells Carousel from Wheaton Regional Park.
- Implement the next phases of infrastructure work on Brookside Gardens, including renovation of the Visitors Center and Conservatory and accessibility improvements to the Formal Gardens.
- Construct the North Branch Hiker-Biker Trail.

#### **Executive Recommendation**

The recommended M-NCPPC budget is \$254.5 million, a \$14.9 million, or 6.2 percent increase from the previously approved budget. Some of this increase is related to expanded efforts to improve water quality in the County through the successful partnership of M-NCPPC and the Department of Environmental Protection in implementing stream restoration projects in support of the County's MS-4 permit .

The Executive's recommendation complies with the Spending Affordability Guidelines (SAG) for M-NCPPC Bonds, which were approved by the County Council at the level then assumed in M-NCPPC's request. The Executive recommends a reduction in G.O. Bonds of \$14.4 million from the M-NCPPC's request. Due to concerns about operating budget affordability, the County Executive generally recommends deferring consideration of current revenue increases until the broader operating budget context is known. The only current revenue increase recommended at this time is for facility planning for the Long Branch Parks Initiative included in the Facility Planning: Non-Local Parks project in FY24. The M-NCPPC Affordability Reconciliation has been adjusted to reflect the practice of deferring current revenue increases until March. The County Executive recommends a two-year delay in M-NCPPC Bond funding in the Urban Park Elements project for a dog park in Norwood Park until alternative locations and community concerns can be considered. A modest deferral of M-NCPPC bonds (-\$105,000) from FY25 to FY26 (\$68,000) and FY27 (\$37,000) was made in the Affordability Reconciliation PDF to accommodate increased inflation assumptions.

# PROGRAM EXPENDITURES

The M-NCPPC's capital program contains two categories of projects: acquisition and development. Acquisition projects allow M-NCPPC to acquire parkland to provide active and passive recreation opportunities, enhance the quality of life for residents, and accommodate conservation and preservation needs. Development projects allow M-NCPPC to manage and maintain the park system through planning, design, and construction activities. Within these categories, the M-NCPPC has two types of projects: level of effort projects which represent maintenance costs that will continue indefinitely and stand alone projects which pertain to a specific parks and projects.

# PROGRAM FUNDING

The M-NCPPC's capital program utilizes a variety of funding sources:

- **Bonds:** General Obligation (G.O.) Bonds are the primary funding source for Countywide (Non-local) parks and M-NCPPC Bonds are used to fund Community Use (Local) parks (See Parks Classification System below).
- Program Open Space (POS) are State funds which can be used for 100 percent of acquisition costs and up to 75 percent of
  development costs. Development projects using POS require matching local funds. POS is the 2nd largest funding source in the
  M-NCPPC's FY23-28 CIP.
- Current Revenues are used to support parkland and facility improvements which are not eligible for debt financing including: planning or improvements where the useful life of equipment or facilities does not equal or exceed the terms of the bonds. Current Revenue: General funds Countywide (Non-local) parks and Current Revenue: M-NCPPC funds Community Use (Local) parks (See Parks Classification System below).
- Enterprise Revenues support the operation of M-NCPPC's self-supporting enterprise fund facilities (tennis courts, skating rinks, train rides, and carousels).
- Long Term Financing: refer to State loan funds, which were first programmed as a funding source in the FY19-24 funding CIP with the assumption that Water Quality Protection Fund (WQPF) revenues will be used to pay the debt service.
- Other funds include State Aid, Revolving Funds, Intergovernmental Funds, Bethesda Park Impact Payments, Contributions, and Federal Aid.

## PARK CLASSIFICATION SYSTEM

Countywide (Non-local) Parks serve all residents of Montgomery County and include:

- Regional Parks: Parks of 200+ acres that generally contain a stream valley, picnic/playgrounds, and interpretive or other natural
  areas, and provide a wide variety of recreational opportunities such as: trails, tennis courts, athletic fields, golf courses, and
  campgrounds.
- Recreational Parks: Parks larger than 50 acres in size which are more intensively developed than Regional Parks and may contain
  athletic fields, tennis and multi-use courts, picnic/playground areas, a golf course, water oriented recreation areas, trails, and
  natural areas.
- Special Parks: Parks which include areas with unique features of historical or cultural significance. Varying in type, they may
  include agricultural centers, gardens, small conference centers or historic sites.
- Urban Parks: Parks which are located in high-density transit-oriented development areas.
- Stream Valley Parks: Interconnected parks along major stream valleys providing picnic and playground areas, hiker-biker and bridle trails, athletic fields, and conservation and recreation areas.
- Conservation Area Parks: Large parks that place primary emphasis on preservation of areas of significant natural value and provide opportunities for compatible passive recreation activities.

Community-Use (Local) Parks serve residents of surrounding communities and include:

- Urban Parks: Parks which are located in Central Business Districts or other highly urban areas.
- Neighborhood Parks: Small parks, providing informal recreation in residential areas with play equipment, play fields, sitting
  areas, shelters, and tennis courts.
- Local Parks: Parks that provide athletic fields and programmed and general recreation facilities such as play equipment, tennis and multi-use courts, sitting/picnic areas, shelters, and other recreational facilities.
- Neighborhood Conservation Areas: Small parcels of conservation-oriented parkland in residential areas, generally dedicated at the time of subdivision.

## STATUTORY AUTHORITY

The Capital Improvements Program (CIP), operating budget, and capital budget for the M-NCPPC are coordinated with the fiscal and capital program requirements of the Montgomery County Charter. The M-NCPPC is required to submit a CIP request to the County Executive and County Council by November 2 of each odd numbered year. This CIP is reviewed by the Executive and included with the Executive's recommendations in the recommended CIP that is submitted to County Council by January 15. After public hearings, the County Council reviews and approves the capital program with such modifications as it deems appropriate. The approved program becomes final upon 30 days written notice to the Commission.

In connection with the approval of the M-NCPPC operating budget, the County Council also approves a capital budget which reflects approved expenditures for the first year of the approved CIP. The M-NCPPC may not undertake any project which is not contained in the first year of the approved CIP. The M-NCPPC Capital budget and CIP are conceptually distinct. The six-year CIP contains the proposed construction and funding schedules for previously approved and newly proposed projects and is subject to County Council modifications. The capital budget provides the appropriation necessary to implement the construction schedule.

# PROJECT DESCRIPTION

This project provides design and construction of water quality improvements and environmental enhancements throughout the park system. This work may include stormwater retrofits, outfall restorations, riparian enhancements, stream restorations, native plantings, non-native invasive plant removals, impervious removals, etc. Improvements may include, but are not limited to, drainage improvements, grading, site work, plantings, signage, infrastructure and utility protection, etc. and are often combined with other projects.

# COST CHANGE

Increase due to the addition of two fiscal years to this ongoing project.

## PROJECT JUSTIFICATION

The project meets Montgomery County's water quality goals, Chapter 19, Article IV of the Montgomery County Code: to protect, maintain, and restore high quality chemical, physical, and biological conditions in the waters of the State in the County. This project is also supported by the Countywide Stream Protection Strategy, Comprehensive Watershed Inventories, and Parks' Phase II NPDES MS4 Permit commitments.

## **OTHER**

The Montgomery Parks Department of the Maryland-National Capital Park and Planning Commission (M-NCPPC) and the Montgomery County Department of Environmental Protection (DEP) have agreed that M-NCPPC will serve as the lead agency for implementing stream restoration projects including long term monitoring and maintenance, that are located wholly or mostly on parkland, and will implement the following additional stream restoration projects in the FY 19-24 CIP through this project; Clearspring Manor, Glenallan, Stoneybrook (Beach Drive to Montrose Avenue), and Grosvenor (Beach Drive to Rockville Pike). Previously, DEP had begun design work on these streams segments which are located predominantly on parkland. In FY18, DEP will provide all design work for these projects to M-NCPPC for design completion, permitting, and construction. M-NCPPC has agreed that all MS4 credits generated from these projects will be credited to the County's future MS4 permit and M-NCPPC must deliver the restored impervious acres no later than Dec. 31, 2023. M-NCPPC will provide appropriate updates at key project milestones to ensure that impervious acreage credits are achieved in the timeframe required, in addition to providing the long-term monitoring and maintenance required for the County to maintain the impervious acreage credit. These projects are currently estimated to have a combined cost of \$2.4M, providing approximately 44 acres of credit. M-NCPPC will utilize its resources for completing design/permitting. M-NCPPC will provide updated schedule and cost information on all projects within FY19 for construction funding allocation from this project beginning in FY20, based on MDE's Water Quality Revolving Loan Fund (WQRLF) cycle timeframes. M-NCPPC and DEP will immediately begin working on an MOU detailing how projects completed by Parks, funded with WQPF dollars, with MS4 credits going to the DEP will be handled. M-NCPPC will document all MS4 credits created through these projects in accordance with MDE requirements to obtain State approval for the Permit credits. M-NCPPC will continue to identify future stream restoration projects throughout the Stream Valley Park system through inter-agency collaboration that provide ecological benefit, infrastructure protection, MS4 credits, and other watershed benefits for future implementation. M-NCPPC recognizes that stream restoration projects with relatively small segments on Park property may be selected by the County's contractor. If selected by the County's contractor and approved by DEP with concurrence from Parks, the County's contractor will need to obtain a Park Permit and comply with all M-NCPPC requirements.

# FISCAL NOTE

Prior year partial capitalization of expenditures through FY16 totaled \$12,854,000. FY13 transfer in of \$129K GO Bonds from Lake Needwood Modifications #098708. Water Quality Current Revenue replaces G.O. Bonds in FY19. Maryland Department of the Environment (MDE) Water Quality Revolving Loan Funds (Long Term Financing) replaces G.O. Bonds in FY20 and beyond. In FY20, \$800,000 in Current Revenue: Water Quality Protection Fund replaces Long Term Financing, and in FY21, \$1,500,000 in Current Revenue: Water Quality Protection Fund replaces Long Term Financing. In addition, \$600,000 in Long Term Financing is slipped to from FY20 to FY21. In FY21, received \$600k in Contributions for the Cabin John Watershed. FY22 appropriation request is \$600,000 less than FY22 expenditures to correct excess appropriation received in FY21 (\$600,000 Long Term Financing that was slipped from FY20 to FY21 was already appropriated in FY20). FY23, replaced \$700k Long-Term Financing with Current Revenue: Water Quality Protection to address delay of loan application while the County and M-NCPPC were negotiating a Memorandum of Understanding to meet loan application and processing of MDE. Additionally, for FY23-28 \$250k Current Revenue: Water Quality Protection replaces Long-Term Financing.

Montgomery County and M-NCPPC entered into a Settlement Agreement with DOJ on August 16, 2011, that required the Country and M-NCPPC to remediate specific issues identified by DOJ within a negotiated timeline, conduct a comprehensive self-evaluation, and develop a Transition Plan for barrier removal, including efforts to comply with the updated Title II requirements.. All self-evaluations were completed ahead of schedule and the Final Transition Plan submitted in August 2016 and subsequently accepted by DOJ. The Final Transition Plan provides a summary of all barriers found, a strategy and timeline for their removal, as well as planning level cost estimates. The Final Transition Plan identified approximately 13,600 barriers with a projected planning level cost estimate of \$31 million for barrier removal system-wide, although actual costs are expected to be significantly higher based upon work completed to date.

#### FISCAL NOTE

Prior year partial capitalization of expenditures through FY16 totaled \$1,934,000.

#### PROJECT DESCRIPTION

The Advance Land Acquisition Revolving Fund (ALARF) was established in the Commission's FY72-FY77 Capital Improvements Program pursuant to Land Use Article Section 18-401 of the Annotated Code of the State of Maryland to enable the Commission to acquire rights-of-way and other property needed for future public projects. ALARF is considered part of the Commission's operating budget, and this CIP project is used to reflect the current Revolving Fund balances in land and available funds. The corpus of the revolving fund includes the original \$7 million bond issue in FY71, a \$5 million bond issue in FY90, a \$2.2 million bond issue in FY95, a \$2 million bond issue in FY95, plus reimbursements in excess of costs, accumulated interest, and any surplus of Advance Land Acquisition (ALA) tax revenue over debt service.

Before acquisition of a specific parcel, the Montgomery County Planning Board will submit an authorization request to the Montgomery County Council for approval by formal resolution. M-NCPPC must seek County Council approval to change the use of ALARF-acquired property. It is the intent of the County Council that land acquisition costs for ALARF-acquired properties will ultimately be appropriated in a specific project PDF or acquisition PDF so that ALARF can be reimbursed and continue to revolve. In the event that the County Council does not require that ALARF be reimbursed, the cost of the land acquisition related to the non-park development project shall be disclosed in the PDF text. If ALARF-acquired properties are not needed for the public use for which they were purchased and/or are used for park and recreation purposes as part of the Commission's Parks system, the Commission is not obligated to replenish ALARF.

#### **COST CHANGE**

Increase due to the addition of two fiscal years to this ongoing project.

#### PROJECT JUSTIFICATION

Some of the acquisitions in this project may help meet 2012 Park, Recreation and Open Space (PROS) Plan objectives. This project enables the Commission to acquire private property in lieu of allowing development that would adversely affect a planned public use of the property. All properties acquired with ALARF must first be shown on adopted area master plans as needed for future public use. Properties included for acquisition in a current capital budget of any public agency are not eligible for acquisition under this project.

#### FISCAL NOTE

Prior year partial capitalization of expenditures through FY16 totaled \$19,337,000. As of the end of FY21, the value of ALARF-acquired land being held for transfer is \$10,176,991. At the end of FY21, the available balance in the ALARF Revolving Fund is \$10,378,064. The amount approved for expenditure from the Revolving Fund by the M-NCPPC Adopted Budget for Fiscal Year 2022 is \$12,557,515.

#### FISCAL NOTE

Addition of \$225k FY22 State Aid, FY22 Bond Bill for Damascus Recreational Park athletic fields. In FY21 and FY22, \$300k in CUPF Current Revenues was swapped with \$300k in G.O. Bonds. #### PROJECT DESCRIPTION

The Bethesda Downtown Plan creates a new approach to providing funds for parks that are critical to livable and healthy communities for the residents of Bethesda and the county. With an increasing population of residents and workers in the Bethesda Downtown Plan area, parks and open spaces have become "outdoor living rooms" and de facto backyards that play an increasingly important role in promoting healthy living, social interaction, and equity. The Bethesda Overlay Zone requires a Park Impact Payment for portions of certain development approvals within the Downtown Plan boundary. Park Impact Payments submitted to the M-NCPPC as a condition of Planning Board development approvals will be placed into this project for appropriation and expenditure. Bethesda PIP funds may be used for acquisition of parkland, site cleanup and interim improvements, renovation/modification of existing parks, and development of new facilities and new parks within the Bethesda Downtown Plan boundary. PIP funds that will be used for full planning, design, and construction of Bethesda parks will be allocated to the appropriate development PDF within the CIP. PIP funds will be allocated based on the park priorities in the Bethesda Downtown Sector Plan, availability of land for acquisition, site improvement needs, and the Parks Departments' design and construction schedule.

#### COST CHANGE

Addition of expenditures in FY23 in anticipation of future contributions.

#### PROJECT JUSTIFICATION

The Bethesda Overlay Zone (ZTA 16-20; adopted 7/18/2017, effective date 8/7/2017)) was created to implement the innovative zoning and community development recommendations in the Bethesda Downtown Plan (2017). This project will serve to hold, appropriate and expend Park Impact Payments made to the M-NCPPC per the requirements of the zoning ordinance.

#### OTHER

Appropriations for payments received above the approved capital budget will be requested through supplemental appropriations or future CIP approvals.

#### PROJECT DESCRIPTION

This project funds the redevelopment of an abandoned maintenance yard by converting it to an environmental-friendly educational site using the principles of Sustainable Education Every Day (SEED) Classroom design and construction. The building will be designed for net-zero energy and water usage, and provides an expansion of the program space for the Black Hill Regional Park Nature Center Program.

#### **ESTIMATED SCHEDULE**

Basis of Design to begin FY21 using existing funding. Design and Construction beginning in FY22.

#### PROJECT JUSTIFICATION

The project site was used as a maintenance yard (MY) until 2004 when it was replaced by a new MY. Black Hill Nature Center and Visitor Center serve more than 35,000 visitors every year. In 2015 alone, the number of people attending the nature center program doubled. With the Cabin Branch Neighborhood currently under construction, the need for additional programming space is expected to increase and the existing 25-person auditorium is falling short of demand to serve the growing community.

#### FISCAL NOTE

In FY22, \$150k slipped from FY22 to FY23 for affordability. FY21 shift of \$250k in State Aid added from Minor New Construction-NL Parks (FY20 Bond Bill).

#### PROJECT DESCRIPTION

The Blair High School athletic field renovation project will include two surfaces which can be used for multiple sports for improved Montgomery County Public School (MCPS) athletic competition for practices and games for the largest high school in Maryland, improved safety and playability for the school's physical education program, and expanded community use in an area of high demand with limited land development opportunities. The proposed improvement projects are separated into two phases as the construction is proposed during a small window during MCPS's summer breaks. #### PROJECT JUSTIFICATION

Blair High School represents a unique opportunity for community recreation - particularly on the lower eastside of the County where land acquisition and athletic field development is extremely limited. Blair High School is one of the largest schools in Maryland and these upgrades provide improved playing conditions for both physical education and competitive sporting events. Montgomery Parks is actively working to increase field inventory and capacity as this section of the County continues to see growth with limited recreation opportunities for both youth and adults. Other investments in the vicinity include the North Four Corners soccer field and the Pinecrest soccer field which are both smaller fields, typically used for youth sports. This project would represent a combination of lighted fields in the Southeastern most part of the County. Outside of Blair High School, the closest lighted diamond fields are at Wheaton Regional Park, and the closest lighted rectangle field is at Martin Luther King Recreational Park. These locations can have long travel times for our lower county residents due to heavy evening traffic. Blair High School already has lights on the baseball, softball, and stadium field. Full-size rectangle fields are extremely limited along the lower section of Route 29. This project would increase recreational opportunities to vital landlocked areas such as Takoma Park. As the facility already has established parking, this project reduces the need for additional impervious surfaces. Ample parking around the current school on weekends provides the community with safe access to these fields. Public transportation is already available through a number of routes that converge on the Four Corners area connecting recreational opportunities to public transportation. Near the intersection of 495 and 95, this site, with a total of three rectangle fields and current parking infrastructure, could handle tournaments on weekends outside of school use. These tournaments draw participants not only from Montgome

#### PROJECT DESCRIPTION

This project provides a new park at 19840 Century Boulevard in the Germantown Town Center. The park will be situated at the northern end of an 8.80 acre parcel of land owned by Montgomery County and shared with the new Germantown Regional Library. Access to this new park will be from Airpark Road. The park consists of three parcels totaling nearly 51 acres: an undeveloped surplus school site, a parcel dedicated through the subdivision process, and adjacent church property purchased by MNCPPC. The new County Animal Shelter is located on a 7-acre portion of the property. The approved plan includes: one full-size lit, irrigated baseball field; one lit synthetic turf field; two rectangular irrigated turf fields; 240 parking spaces with the potential for 50 additional spaces in the future if needed; playground; basketball court; combination restroom picnic shelter; and trails.

# PROJECT DESCRIPTION

The Legacy Open Space initiative identifies open space lands that should be acquired and interpreted because of exceptional natural or cultural value to current and future generations of Montgomery County residents. The project funds acquisition (in-fee and easement) of open-space lands of countywide significance. Priorities are updated during each CIP cycle but remain flexible to allow the Montgomery County Planning Board to address development threats, opportunity acquisitions, and joint funding opportunities. #### PROJECT DESCRIPTION

The Energized Public Spaces Functional Master Plan (EPS Plan) is a countywide plan to provide public spaces within walking distance in the county's most densely populated areas. #### PROJECT DESCRIPTION

The central portion of Montgomery County continues to experience population and economic growth. The 2010 White Flint Sector Plan, the 2017 Rock Spring Sector Plan, the 2018 White Flint 2 Sector Plan, and the 2018 Grosvenor-Strathmore Metro Area Minor Master Plan support this growth by creating livable communities that offer a range of benefits such as walkable neighborhoods and access to community facilities including parks. These funds are intended to create new park resources, so will not be used not for the renovation/modification of existing parks. Funds that are allocated for planning, design, and construction of parks will be transferred to the appropriate development PDF within the CIP. Expenditures will be based on the park priorities within each of the Master/Sector Plan areas, availability of land for acquisition, site improvement needs, and the Parks Departments' design and construction schedule.

#### **COST CHANGE**

Appropriation added to receive anticipated contributions.

#### PROJECT JUSTIFICATION

Chapters 50 (Subdivision Regulations) and 59 (Zoning Ordinance) of the Montgomery County Code require development/redevelopment to demonstrate substantial conformance with the Master or Sector Plan for approval. # PROJECT DESCRIPTION

Funded in FY22 by a Maryland Local Parks and Playgrounds grant earmarked by the State of Maryland for the "Pepco Powerline Trail project," this project will design, construct, and equip portions of the ultimate 13-mile paved and natural surface trail within the Pepco powerline corridor that connects South Germantown Recreational Park to Cabin John Regional Park as well as community and park connectors along the corridor. #### PROJECT DESCRIPTION

This project provides design and construction of water quality improvements and environmental enhancements throughout the park system. ## PROJECT JUSTIFICATION

This project is also supported by the Countywide Stream Protection Strategy, Comprehensive Watershed Inventories, and Parks' Phase II NPDES MS4 Permit commitments.

# **OTHER**

The Montgomery Parks Department of the Maryland-National Capital Park and Planning Commission (M-NCPPC) and the Montgomery County Department of Environmental Protection (DEP) have agreed that M-NCPPC will serve as the lead agency for implementing stream restoration projects including long term monitoring and maintenance, that are located wholly or mostly on parkland, and will implement the following additional stream restoration projects in the FY 19-24 CIP through this project; Clearspring Manor, Glenallan, Stoneybrook (Beach Drive to Montrose Avenue), and Grosvenor (Beach Drive to Rockville Pike). Previously, DEP had begun design work on these streams segments which are located predominantly on parkland. In FY 18, DEP will provide all design work for these projects to M-NCPPC for design completion, permitting, and construction. M-NCPPC has agreed that all MS4 credits generated from these projects will be credited to the County's future MS4 permit and M-NCPPC must deliver the restored impervious acres no later than Dec. 31, 2023. M-NCPPC will provide appropriate updates at key project milestones to ensure that impervious acreage credits are achieved in the timeframe required, in addition to providing the long-term monitoring and maintenance required for the County to maintain the impervious acreage credit. These projects are currently estimated to have a combined cost of \$2.4M, providing approximately 44 acres of credit. M-NCPPC will utilize its resources for completing design/permitting. M-NCPPC will provide updated schedule and cost information on all projects within FY19 for construction funding allocation from this project beginning in FY 20, based on MDE's Water Quality Revolving Loan Fund (WQRLF) cycle timeframes. M-NCPPC and DEP will immediately begin working on an MOU detailing how projects completed by Parks, funded with WQPF dollars, with MS4 credits going to the DEP will be handled. M-NCPPC will document all MS4 credits created through these projects in accordance with MDE requirements to obtain State approval for the Permit credits. M-NCPPC will continue to identify future stream restoration projects throughout the Stream Valley Park system through inter-agency collaboration that provide ecological benefit, infrastructure protection, MS4 credits, and other watershed benefits for future implementation. M-NCPPC recognizes that stream restoration projects with relatively small segments on Park property may be selected by the County's

contractor. If selected by the County's contractor and approved by DEP with concurrence from Parks, the County's contractor will need to obtain a Park Permit and comply with all M-NCPPC requirements.

#### FISCAL NOTE

Prior year partial capitalization of expenditures through FY16 totaled \$12,854,000. FY13 transfer in of \$129K GO Bonds from Lake Needwood Modifications #098708. # PROJECT DESCRIPTION

Warner Circle Special Park (WCSP), located in the heart of the Kensington Historic District, was the home of Brainard Warner, the founder of the Town of Kensington and a significant figure in the development of Montgomery County. This 4.5-acre park was acquired through the Legacy Open Space program to preserve historic structures and valuable public open space in a down county location. This PDF funds (1) repair work to stabilize the manor house and carriage house in preparation for adaptive reuse and (2) improvements to the parkland surrounding the historic structures to create an attractive and functional park. Park improvements funded by this project to date include: demolished nursing home wings and restored associated parkland; addressed deferred maintenance of significant trees and landscaping; re-created the historic loop road; and stabilized the main house by reconstructing historic exterior walls, repairing damaged porches and roof areas, and rebuilding the rear stone terrace.

After a lengthy search for an appropriate adaptive reuse, the historic structures are proposed to be sold to a residential developer specializing in historic structures via a condominium regime that would retain the park in public ownership save for an approximate 6-foot buffer around the buildings. The disposition and conversion of the buildings into private residences will be governed by an existing Maryland Historical Trust preservation easement, Historic Preservation Commission review, and other binding legal contracts to ensure the preservation of the historic resources and appropriate integration of the private units into a well-used and well-loved public park, including full public access to the park grounds and some public access to the historic buildings and terraces for special events. If disposition of the buildings for residential conversion does not proceed, public private partnerships or other tools to achieve appropriate adaptive reuse will be pursued. This PDF will continue to fund improvements to the public amenities on this significant historic park.

#### ESTIMATED SCHEDULE

Phase I completed in FY14. Structural stabilization complete in 2017. Negotiations are ongoing with potential unsolicited partner.

Dear President Albornoz:

On January 18, the County Executive released the Recommended FY23-28 Capital Improvements Program (CIP) and FY23 Capital Budget. I have had the opportunity to work with the Planning Board and staff in the Parks Department to review his recommendations, which include reductions of \$19.4million to the Department's transmittal of November 1, 2021.

The Department's current proposal for FY23-28 is responsive to the challenging economy and represents what we feel is the minimum required to adequately support the park system. However, we understand the importance of working with the County Executive and Council to manage a difficult budget and would like to help the Council understand the impacts of the Executive's recommended CIP as you begin your deliberations on the CIP.

If the Executive's budget is enacted, the following consequences will result by capital project:

- Blair HS Field Renovations and Lights (P872105) Field #2 will be delayed beyond FY28, (\$1.5M)
- <u>Brookside Gardens Master Plan Implementation (P078702)</u>- Budget for current phase related renovations to the Formal Gardens and the Conservatory will be reduced \$219k in FY24
- <u>Facility Planning: NL (P958776)</u> Funding will be reduced for the Capital Crescent Trail (CCT) in FY23 by \$200k.
- <u>Legacy Open Space (P018710)</u> Funding will be reduced \$2.9623M (\$300k in FY23-24 in Current Revenue: General, and \$2.623M FY25-28 in GO bonds), should critical acquisition opportunities arise during this time that would otherwise depend on this funding, we will likely approach the Council with supplemental budget requests
- Northwest Branch Recreational Park Athletic Area (P118704) Start of construction will be delayed from FY26 to FY28, (\$500k)
- Ovid Hazen Wells Recreational Park (P871745) Construction will be extended approximately 6 Months while a portion of FY25 funding moves into FY26, (\$580k)
- Planned Lifecyle Asset Replacement (PLAR): Local Parks-Resurfacing Lots and Paths (P871546) \$105k will be delayed from FY25 into FY26 (\$68k) and FY27 (\$37k)
- PLAR: NL Minor Renovations (P998708) Level of Effort will be reduced \$4.5M in FY23-28, limiting our ability to address a backlog of renovations and maintenance system-wide among the 37,000 acres of parks

- PLAR: NL Play Equipment (P998709) The Adventure Playground renovation in S. Germantown Recreational Park will be slowed approximately 6 months while a portion of FY25 moves into FY26, (\$200k)
- Resurfacing Park Roads and Bridge Improvements (P500720) This capital project is part of the MCDOT CIP but has a significant impact on the parks. This project provides for the rehabilitation and/or renovation of park roads in Stream Valley Parks, e.g., Sligo Creek Parkway, Beach Drive, Little Falls Parkway, which have been a primary means of accessing and connecting county residents to parks during the pandemic and are subject to unique pressures from storm events and environmental constraints. The program includes pavement renovation, traffic safety controls, drainage improvements, bridge repairs, roadside safety improvements, etc. that are difficult to sustain at current funding. The Department requested an increase of \$200k/year to adequately maintain safe public access to these parks.
- <u>S. Germantown Recreational Park: Cricket Field (P871746)</u> Construction will be delayed four years from FY23 to FY27 (\$981k)
- <u>Urban Park Elements (P871540)</u> While the overall capital project has a net zero effect over 6-years, it will leave no M-NCPPC Bonds for FY23, delaying other important projects in Energized Public Spaces portions of the county, and does not address the County Executive's concerns for a dog park.
- Wheaton Regional Park Improvements (P871904) Construction will be delayed two years to FY26 and \$9.55M delayed beyond FY28. With the coming master plan update, the Department will soon revisit the scope and funding of this capital project in the next CIP. In the meantime, the Department has been looking at ways to implement projects that increase connectivity to the park and provide necessary renovations to aging, failing infrastructure.

These or other equivalent impacts will occur if the County Council does not restore funding to the Parks CIP. While the CIP we transmitted to you in November is what we feel is the minimum required to adequately support the park system, we have proposed recommendations below including restorations to proposed reductions and delays that we will present in prioritized tiers.

### Recommendations

- Delay \$105k of M-NCPPC Bonds in FY25 in the <u>Planned Lifecyle Asset Replacement (PLAR): Local Parks-Resurfacing Lots and Paths (P871546)</u> capital project shifting the delayed funds into FY26 (\$68k) and FY27 (\$37k)
- Reject the County Executive's recommendation to delay M-NCPPC Bond funding in the <u>Urban</u> <u>Park Elements</u> (P871540) capital project
- Increase funding for the <u>Resurfacing Park Roads and Bridge Improvements</u> (P500720) capital project by \$200k/year

Should the Council consider other approaches within the CIP, priorities that we want to protect include:

- Annual funding for lifecycle replacement and repair of park infrastructure and amenities including playgrounds, trails, tennis courts and basketball courts.
- Annual funding to support trail construction and maintenance and our Vision Zero initiative to ensure the safety of road crossings for trail and park users.
- Annual funding to improve the quality of park athletic fields.
- Annual funding to provide activating amenities in urban parks.
- Annual funding to meet mandates including the Americans with Disabilities Act and the Clean Water Act.
- The 2nd Cricket Field at South Germantown Recreational Park, Northwest Branch Recreation Park, and Wheaton Regional Park.

Attached you will find a copy of the County Executive's affordability PDF for M-NCPPC, summary tables of the Department's non-recommended reductions, and marked up PDFs for the capital projects that would be affected should the Council require the full reductions recommended by the County Executive. The Department's position and that of the Planning Board is that the Council should fully fund the Department's request. This is because:

#### **PROJECT DESCRIPTION**

The Blair High School athletic field renovation project will include two surfaces which can be used for multiple sports for improved Montgomery County Public School (MCPS) athletic competition for practices and games for the largest high school in Maryland, improved safety and playability for the school's physical education program, and expanded community use in an area of high demand with limited land development opportunities. The proposed improvement projects are separated into two phases as the construction is proposed during a small window during MCPS's summer breaks. Both fields are proposed to have investments into soils, grading, drainage, lighting and irrigation to promote improved playability and safety for both the community and Blair High School students.

- Phase one of the project will focus on the track field with improvements to include irrigation, drainage, grading, bermudagrass, portable goals and lights.
- Phase two of the project will focus on the multi-purpose field directly behind the school with improvements to include irrigation, grading, bermudagrass, softball infield improvements, portable goals and lights.

# **LOCATION**

# **PROJECT JUSTIFICATION**

Blair High School represents a unique opportunity for community recreation - particularly on the lower eastside of the County where land acquisition and athletic field development is extremely limited. Blair High School is one of the largest schools in Maryland and these upgrades provide improved playing conditions for both physical education and competitive sporting events. Montgomery Parks is actively working to increase field inventory and capacity as this section of the County continues to see growth with limited recreation opportunities for both youth and adults. Other investments in the vicinity include the North Four Corners soccer field and the Pinecrest soccer field which are both smaller fields, typically used for youth sports. This project would represent a combination of lighted fields in the Southeastern most part of the County. Outside of Blair High School, the closest lighted diamond fields are at Wheaton Regional Park, and the closest lighted rectangle field is at Martin Luther King Recreational Park. These locations can have long travel times for our lower county residents due to heavy evening traffic. Blair High School already has lights on the baseball, softball, and stadium field. Full-size rectangle fields are extremely limited along the lower section of Route 29. This project would increase recreational opportunities to vital landlocked areas such as Takoma Park. As the facility already has established parking, this project reduces the need for additional impervious surfaces. Ample parking around the current school on weekends provides the community with safe access to these fields. Public transportation is already available through a number of routes that converge on the Four Corners area connecting recreational opportunities to public transportation. Near the intersection of 495 and 95, this site, with a total of three rectangle fields and current parking infrastructure, could handle tournaments on weekends outside of school use. These tournaments draw participants not only from Montgome

## **PROJECT DESCRIPTION**

The Legacy Open Space initiative identifies open space lands that should be acquired and interpreted because of exceptional natural or cultural value to current and future generations of Montgomery County residents. The project funds acquisition (in-fee and easement) of open-space lands of countywide significance. Priorities are updated during each CIP cycle but remain flexible to allow the Montgomery County Planning Board to address development threats, opportunity acquisitions, and joint funding opportunities. The County Council encourages the Commission to seek supplemental appropriations if approved CIP funding is insufficient.

Non-County funding sources are expected to contribute significantly to the Legacy Open Space program. Contributions will appear in the PDF Expenditure and Funding Schedules only if the contribution is spent by the County or M-NCPPC. Donations of land or non-County funded payments that go directly to property owners are not included. The combination of these non-County funds have resulted in the successful protection of over 5,400 acres of open space in the County, including over 3,850 acres of new parkland.

## **COST CHANGE**

Addition of FY27-28. Beyond Six Year costs adjusted to maintain the historical project balance of \$100 million.

#### **PROJECT JUSTIFICATION**

The Vision 2030 Strategic Plan for Parks and Recreation in Montgomery County (2010) and the 2017 Park, Recreation and Open Space (PROS) Plan recommend placing priority on conservation of natural open spaces, protection of heritage resources, providing critical urban open spaces, and expanded interpretive activities in parks. Legacy Open Space: Open Space Conservation in the 21<sup>st</sup> Century, approved by the Montgomery County Planning Board in October 1999. Legacy Open Space Functional Master Plan adopted by the County Council in July 2001.

# **FISCAL NOTE**

Reduction in FY22 Current Revenue: General from non-recommended reductions, and G.O. Bonds were reduced in FY23-25 and slipped to FY26 for fiscal capacity. Projects will be added based on the Wheaton Master Plan update and ongoing needs assessments.

## **COST CHANGE**

Increase reflects introduction of funding that was being held beyond the six years of the prior CIP and to implement the recommendations of the Wheaton Regional Park Master Plan.

This project is within the recommendations of the Wheaton Regional Park Master Plan, VISION 2030: Strategic Plan for Parks and Recreation in Montgomery County, Maryland, 2017 Park, Recreation and Open Space (PROS) Plan as well as ADA Transition Plan that was submitted to the Department of Justice (DOJ).

I am reaching out to you regarding yet another potential delay of Ovid Hazen Wells Recreational Park as part of M-NCPPC non-recommended reductions and urge you to keep this unique and important Upcounty park on its current schedule. This park has been delayed numerous times over the past years to the detriment of Clarksburg residents who have limited active outdoor space and community greens.

The Upcounty is the fastest growing area in Montgomery County. Clarksburg is a family-oriented area, and active recreation space is critically needed for our residents. Ovid Hazen Wells Recreational Park is envisioned to be an outdoor community hub, with playground area, trails, amphitheater, community green and a historic carousel. It is slated to be a family destination for our Clarksburg residents.

Similarly, the South Germantown Cricket Field fulfills a tremendous need upcounty in providing our residents with a much needed amenity. With several cricket leagues in the area, an additional field will serve both adults and youth in accessing this fast growing sport.

I urge the PHED Committee to fulfill a long-standing commitment the county has made to the upcounty residents and keep these projects on their current schedules with no further delays. As we have found during the pandemic, active outdoor space is not just an amenity, it's a necessity.
